Red Eagle Soaring is a nonprofit Native Youth Theatre offering free arts education to American Indian and Alaska Native youth ages 9-20 Red Eagle Soaring integrates contemporary theatre with traditional Native performing arts, empowering Native youth to express themselves, take creative action on the issues that affect their lives, and sustain their culture Red Eagle Soarings 2013 cycle of programming consisted of Spring Play A cast of 24 RES youth worked for 5 months to write, develop, rehearse, and stage I Am Alive, a musical comedy exploring racial stereotypes, inspired by the questions non-Natives ask of Native youth, and culminating in a free public performance for a full house on June 16th, 2013 at Rainier Valley Cultural Center in Seattle RES youth wrote, filmed, and edited a video trailer for the play, which can be seen here http://www.youtube.com/watch?v=J0U4dc1J15Y This project was an opportunity for youth to learn how to plan for and manage a play production, write and edit as a collaborative team, sing and dance, and most importantly, to think critically about the answers to questions from non-Natives like, What is sovereignty?, Do you have lots of casino money?, and Is your culture dying? Yakama Nation Theatre Residency In July, RES visited the Yakama Nation for our 4th theatre and multi-media residency at the Yakama Heritage Cultural Centers Theatre in Toppenish, Washington The residency brought together 15 urban Indian RES youth and 30 Yakama reservation youth for a collaborative staging of Wormface, a traditional Yakama story, culminating in a free public performance for a full house at the beautiful Yakama Heritage Theatre This was an opportunity for reservation and urban Native youth to meet again and build upon four years of shared experiences in cultural collaboration S I Y A P (Seattle Indian Youth Arts and Performance) A cast of 31 youth participated in a two-week performing arts camp held at Daybreak Star, culminating in a performance of As Long As The Rivers Run, an original musical about salmon and Native fishing rights based on the traditional story of Salmon Boy (adapted for the stage by Lower Elwha Sklallam tribal member Roger Fernandes), for audiences at EMP Museum on August 17th, 2013 Youth attended from throughout greater Seattle and were mentored by Native teaching artists and community volunteers, bonded and formed a peer group with other Native teens, learned traditional songs and stories, camped out at Daybreak Star, experienced the spiritual and health benefits of the sweat-lodge, learned about and ate traditional foods, learned about salmon biology and threats to salmon survival, learned about the Northwest Native fishing rights struggle, the Boldt decision and its implications for tribal sovereignty, and drew powerful connections between making art and mobilizing public action to save salmon As Long As The Rivers Run on youtube http://www.youtube.com/watch?v=mfvGbtfoMWE Student produced behind the scenes mini-documentary about As Long As The Rivers Run http://www.youtube.com/watch?v=VXDu1X\_B6LA Fall Program A cast of 21 RES youth rehearsed for ten weeks to stage an updated As Long As The Rivers Run, culminating with a free public performance at Seattles Rainier Valley Cultural Center on December 15th, 2013
