It provides engaging and entertaining exhibitions for a broad spectrum of the community, a retail store which includes educational materials and a café. To enhance the visitor experience, the Museum offers racing simulators and slot car driving. Attendance June 2013 = 170,000.

Club Auto is a special membership in addition to the Museum's general membership program. Members of Club Auto are provided a safe space to display their collector cars and share their knowledge with other automobile enthusiasts through educational speakers and car shows. Patrons unable to attend the Museum during normal operating hours are offered the opportunity to view the collection during after-hours events through the Museum's Event Sales program. The Museum also provides its visitors with a store to purchase educational materials and a café.
