IT IS ESTIMATED THAT BY THE END OF 2013, COUNTRIES HAD PREVENTED MORE THAN 6.2 MILLION FUTURE DEATHS WITH THE HELP OF GAVI ALLIANCE -SUPPORTED VACCINES. IN 2013, PROJECTIONS INDICATE APPROXIMATELY 48 MILLION CHILDREN WERE IMMUNIZED WITH GAVI-SUPPORTED VACCINES.
