16 **I. Purpose of Agreement; Identity of Trust.** In accordance with RCW
17 11.96A.220, this agreement (the "Agreement") is entered into for the purpose of
18 addressing issues regarding the administration of the trust (the "Trust") created for and
19 currently existing for the benefit of charitable organizations pursuant to that Trust
20 Agreement (the "Trust Agreement") dated December 15, 1999 between David R. Bishop
21 and Lynda F. Bishop (the "Settlers") and David R. Bishop, Lynda F. Bishop, Ginger
22 Schmersal, and Amanda Bishop (the "Trustees"). A copy of the executed Trust
23 Agreement is attached as Exhibit A.

24 **II. Parties.** The parties to this Agreement are:

25 **A. David R. Bishop, Lynda F. Bishop, Ginger Schmersal, and**
26 **Amanda Bishop**, in their capacities as the Trustees; and

27 **B. Attorney General of the State of Washington**, on behalf of the
charitable beneficiaries

The parties identified above (the "Parties") include all of the beneficially
interested parties, as defined in RCW 11.96A.110 and RCW 11.96A.120, and all parties
to whom notice must be sent under RCW 11.96A.110.

III. Description of Trust.

The Trust was created pursuant to Article FIRST of the Trust Agreement. Article
TENTH of the Trust Agreement provides that the Trust is irrevocable, and that the

1 Settlers have no power, in any capacity, whether alone or in conjunction with another, to
2 alter, amend, revoke, or terminate the Trust Agreement or any terms thereof. Article
3 ELEVENTH provides a limited exception to the restriction on amendment set forth in
4 Article TENTH, only to the extent necessary to ensure the Trust's continued qualification
5 as an organization described in Section 501(c)(3), contributions to which are deductible
6 for federal tax purposes.

7 Article THIRD of the Trust Agreement provides that the Trust was created for,
8 and is to be operated exclusively for, "religious, charitable, scientific, literary, or
9 educational purposes within the United States or any of its possessions, as those terms are
10 interpreted and applied in Section 501(c)(3) of the Internal Revenue Code" The
11 Trust Agreement does not name any specific organizations as beneficiaries. Article
12 FIFTH paragraph (A) of the Trust Agreement provides that the Trustees shall make
13 sufficient distributions for charitable purposes to comply with Section 4942 of the
14 Internal Revenue Code (the "Code"). Article FIFTH paragraph (B) provides that no
15 distribution is to be made which is not authorized by the Trust Agreement and permitted
16 to be made by a trust described in Section 501(c)(3) of the Internal Revenue Code (the
17 "Code"). Article SEVENTH paragraph (B)(1) provides that the Trust's assets must be
18 held and administered in such a manner that the Trust shall qualify as an organization
19 described in Section 501(c)(3), and further that the Trust shall not conduct or carry on any
20 activities not permitted to be conducted or carried on by an organization described in
21 Section 501(c)(3).

22 Article SEVENTH paragraph (B)(2) provides that the Trust assets must be held
23 and administered in compliance with RCW 11.110.210-220, which restrict the Trustees
24 from engaging in certain conduct which would give rise to excise tax liability for a
25 private foundation under the provisions of Chapter 42 of the Code. Article SEVENTH
26 paragraph (B)(3) provides that the Trust Agreement shall be construed, interpreted, and
27

(if necessary) modified or limited such that the provisions of the Trust comply with statutory requirements for Section 501(c)(3) organizations and with RCW 11.110.210-220.

In 2000, the Trust received a determination letter from the Internal Revenue Service ("IRS") stating that the Trust was an organization described in Section 501(c)(3) of the Code, a copy of which is attached as Exhibit B. The determination letter further classified the Trust as a private foundation within the meaning of the federal tax law.

Article SIXTH paragraph (A) of the Trust Agreement provides that the Trust shall terminate when the last of the four "Family Trustees" (who are the four current Trustees) fails or ceases to serve, unless the Trustees decide otherwise pursuant to a periodic review of the trust term, the procedure for which is set forth in Article SIXTH paragraph (C).

Article SIXTH paragraph (D) of the Trust Agreement provides that the then serving Family Trustees shall meet annually to determine by unanimous vote the organizations to which the Trust shall make charitable distributions in the event of the Trust's termination pursuant to Article SIXTH paragraph (A). Article SIXTH paragraph (B) provides that the Trustees may also terminate the Trust by unanimous vote, provided that they distribute the Trust's assets to organizations described in Sections 501(c)(3), contributions to which are deductible under Section 170, and not to any Trustee or other private individual.

Article EIGHTH paragraph (B) provides that the Family Trustees may, but are not required to, designate a successor Trustee for any Family Trustee who ceases or fails to serve. Article EIGHTH paragraph (E) provides that Family or successor Trustees shall not be compensated for attending meetings of the Trustees, but may be compensated as determined by the Trustees for services rendered in addition to attending meetings of the Trustees.

IV. Subject Matter At Issue and Purpose of Agreement.

1 The Trustees have unanimously determined that they wish to make certain
2 changes to the procedures described in Articles SIXTH and EIGHTH of the Trust
3 Agreement concerning termination of the Trust and succession of Trustees who cease or
4 fail to serve. The intended changes are reflected in the restated and amended form of the
5 Trust Agreement attached hereto as Exhibit C. A redline comparison of the restated and
6 amended form of the Trust Agreement attached hereto as Exhibit C with the original
7 Trust Agreement is attached hereto as Exhibit D.

8 The Trustees do *not* intend to change the requirements of the Trust Agreement
9 that Trust assets be distributed exclusively to organizations described in Section 501(c)(3)
10 of the Code which are eligible to receive deductible contributions under Section 170, that
11 the Trust be operated exclusively for religious, charitable, scientific, literary, or
12 educational purposes within the United States or any of its possessions, and in a manner
13 otherwise consistent with the law governing Section 501(c)(3) organizations; and that the
14 Trust be operated in a manner consistent with the provisions and prohibitions of RCW
15 11.110.210-220.

16 The Trustees intend to cause the Trust to terminate upon the death of the second
17 Settlor (rather than when the last Family Trustee ceases to serve), unless, following the
18 death of one Settlor, the surviving Settlor elects to extend the term of the Trust by a
19 period of up to seven (7) years from the death of the surviving Settlor.

20 The Trustees further intend that Norma Oliason, an experienced Certified Public
21 Accountant unrelated to the Family Trustees, shall serve as an "Overseer Trustee" in the
22 event of the death of both Settlers. In the event of the Trust's termination on the death of
23 both Settlers, the Trustees intend that Ms. Oliason would become the sole Trustee; all
24 other surviving Trustees would cease their service as Trustees; and Ms. Oliason, as
25 Overseer Trustee, would distribute the Trust's assets upon the Trust's termination to those
26 Section 501(c)(3) organizations selected pursuant to Article SIXTH paragraph (D). In the
27

1 case where the last surviving Settlor extends the term of the Trust beyond the death of
2 both Settlor, the Trustees intend that Ms. Oliason would serve as Overseer Trustee
3 alongside the surviving Family Trustees for the remaining term of the Trust, at the end of
4 which the remaining Trustees would distribute the Trust's assets to those Section
5 501(c)(3) organizations selected pursuant to Article SIXTH paragraph (D).

6 If Ms. Oliason is unwilling or unable to serve as Overseer Trustee as provided
7 under this Agreement, then the Trustees intend that those Trustees surviving upon the
8 second Settlor's death unanimously select an alternate Overseer Trustee. If the surviving
9 Trustees are unable within six (6) months of the second Settlor's death unanimously to
10 select an alternate Overseer Trustee, then the Trustees intend that the Trust shall terminate
11 and the surviving Trustees distribute the Trust's assets to those Section 501(c)(3)
12 organizations selected pursuant to Article SIXTH paragraph (D).

13 The Trustees intend that, in the event that Ms. Oliason serves as Overseer Trustee,
14 she may appoint a successor Overseer Trustee, or, if she ceases or fails to serve without
15 appointing a successor Overseer Trustee, then Rick Starkenburg, an experienced Certified
16 Public Accountant unrelated to the Family Trustees, shall serve as the successor Overseer
17 Trustee. If Mr. Starkenburg is unwilling or unable to serve as the successor Overseer
18 Trustee, then the Trustees intend that those Family Trustees who are still serving will
19 unanimously select a successor Overseer Trustee.

20 The Parties enter into this Agreement in order to amend the relevant provisions of
21 the Trust Agreement consistent with the intent of the Trustees as described above, and
22 with the provisions of RCW 11.96A.210-230 and of the Trust Agreement.

23 **V. Agreement**

24 In order to resolve the above matter and to facilitate the administration of the
25 Trust, the Parties hereby agree as follows:
26
27

1 A. The Parties hereby agree that a restated and amended version of
2 the Trust Agreement in the form attached hereto as Exhibit C shall supersede the
3 current Trust Agreement, effective immediately upon the execution of both this
4 Agreement and such restated and amended version of the Trust Agreement, and the
5 terms of such restated and amended version of the Trust Agreement shall govern the
6 administration of the Trust.

7 B. The Parties hereby agree that the adoption of a restated and
8 amended version of the Trust Agreement shall not alter, in any way, the Trustees'
9 ongoing obligations to hold and administer the Trust in such a manner that (1) the Trust
10 shall at all times qualify as an organization described in Section 501(c)(3) of the Code,
11 contributions to which are deductible under Section 170 of the Code; (2) the Trust shall
12 not carry on any activities not permitted to be conducted or carried on by an
13 organization described in Section 501(c)(3) of the Code; and (3) the administration of
14 the Trust is in accord at all times with the provisions of RCW 11.110.210-220.

15 **VI. Filing of Agreement and Waiver of Notice.** The Parties agree that no
16 Party shall file a copy of this Agreement with the Superior Court of Washington for King
17 County, but that the Trustees or their agent will file a memorandum thereof with the
18 Superior Court of Washington for King County. Each party waives any notice
19 requirement of the filing of such memorandum with the Superior Court of Washington for
20 King County. The Parties agree that this Agreement shall be binding as a final order
21 upon the filing of such memorandum thereof, all in accordance with RCW 11.96A.230.

22 **VII. Situs and Law Governing Administration.** The Parties agree that the
23 present situs of the Trust is Washington State and, therefore, questions of construction as
24 well as administrative and procedural matters, including the questions and matters
25 contained herein, are properly governed by the laws of Washington.


1 **VIII. Binding on Successors.** This Agreement shall be binding upon the heirs,

3 **IX. Counterpart Documents; Effective Date.** This Agreement may be
4 executed by the Parties' signatures on duplicate counterpart documents, which will have
5 the same force and effect as if all of the Parties had executed a single document. This
6 Agreement shall be effective for all purposes when all of the parties have signed this
7 Agreement or counterparts thereof. The execution of this Agreement by facsimile







ALTA FOUNDATION

THIS TRUST AGREEMENT ("Agreement") is made this 18th day of September, 2013, between DAVID R. BISHOP and LYNDIA F. BISHOP, as donors (the "Donors"), and DAVID R. BISHOP, LYNDIA F. BISHOP, GINGER SCHMERSAL and AMANDA BISHOP, as Trustees (DAVID R. BISHOP, LYNDIA F. BISHOP, GINGER SCHMERSAL and AMANDA BISHOP and any additional or successor Trustee or Trustees being sometimes individually referred to as "Trustee" or collectively referred to as the "Trustees").

WITNESSETH:

FIRST: Creation of Trust.

(A) **Property Delivered.** The Donors are delivering to the Trustees the property listed on the attached Schedule A and receipt of which the Trustees have acknowledged.

(B) **Property Held in Trust.** Such property transferred, and any other property hereafter transferred to the Trustees and deemed acceptable by the Trustees, shall be held in trust pursuant to the terms and conditions set forth in this Trust Agreement.

SECOND: Name of Trust.

The name of this Trust shall be "ALTA FOUNDATION", and so far as practicable, the Trustees shall conduct the activities of this Trust in such name.

THIRD: Purpose of Trust.

(A) **General Purpose.** This Trust is created for and shall be operated exclusively for religious, charitable, scientific, literary, or educational purposes within the United States or any of its possessions, as those terms are interpreted and applied in Section 501(c)(3) of the Internal Revenue Code (the "Code"), or any successor provision, including without limitations, making grants to assist disadvantaged children, to support education, including funding scholarships and low-interest education loans, to support arts education and availability, and to support organizations that promote economic self-help for the needy. No part of the Trust Estate (as that term is defined in Article FOURTH below), whether income or principal, shall inure to the benefit of the Trustees, or any of them, or any private individual (except that reasonable compensation may be paid for services rendered to or for this Trust affecting one or more of its purposes), and no substantial part of the activities of this Trust shall, within the meaning of Section 501(c)(3), consist of carrying on propaganda, or otherwise attempting, to influence legislation, and no part of its activities shall consist of participating in, or intervening in, including the publication or distribution of statements, any political campaign on behalf of any candidate for public office. Anything in this Agreement to the contrary notwithstanding, this Trust shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization which is exempt from taxation under Section 501(c)(3) and/or by an organization

to which donations are deductible for federal income, gift, and estate tax purposes to the extent allowed by the Code and other applicable law now in effect or as amended from time to time.

FOURTH: Trust Estate.

The Trustees shall have the authority to receive donations from the Donors and from any other source, in cash, securities, and other property (real or personal) acceptable to them. All property so received by the Trustees, together with the income and proceeds thereof (the "Trust Estate"), shall be held, administered, and distributed by the Trustees pursuant to the provisions of this Agreement. The Trustees may accept donations which restrict their uses and purposes, provided that such restrictions are within the uses and purposes set forth in Article THIRD above, and which limit the time, manner, amount, or other terms of distribution; provided, however, that unless otherwise specifically required, the Trustees shall have the power in their discretion to mingle such restricted donations with other assets of this Trust.

FIFTH: Disposition of Trust Property.

(A) **Distributions for Charitable Purposes.** The Trustees shall manage, invest, and reinvest the Trust Estate and shall pay or apply so much of the net income and principal of the Trust at such times and in such manner as the Trustees determine in their discretion (or as may be required by restricted donations), to and for the uses and purposes set forth in Article THIRD above. In all events, at any time during which this Trust does not qualify as an operating foundation within the meaning of Section 4942(j)(3), the Trustees shall distribute the net income for each taxable year of this Trust at such time and in such manner so as not to become subject to the tax on undistributed income imposed by Section 4942. Any income not so paid or applied shall be accumulated and annually added to and dealt with as principal.

(B) **Other Distributions Prohibited.** The Trustees shall make no distribution from the Trust other than distributions specifically authorized by the terms of this Agreement and permitted to be made from a trust exempt from tax under Section 501(c)(3). However, an amount shall not be deemed to be paid to, or for the use of, any person if the amount is transferred for full and adequate consideration. If the Trustees inadvertently make any prohibited distribution, the Trustees shall recover such distribution from the recipient.

SIXTH: Termination of the Trust.

(A) **Termination of Trust.** This Trust shall terminate upon the death of the second of the Donors to die, provided, however, that if one of the Donors shall survive the other, the survivor shall have, in his or her capacity as a Trustee, the power, acting alone, to amend this Agreement, in his or her discretion, solely for the purpose of extending the term of the Trust for a period not to exceed seven (7) years following the death of the survivor.

(B) **Termination by Unanimous Vote.** At any time, the then serving Family Trustees may terminate this Trust by unanimous vote, and, in their discretion, shall distribute the Trust Estate to such organizations and in such amounts as the then serving Family Trustees shall determine, by unanimous vote, provided that any organization so selected is then a qualified charitable organization described in Sections 501(c)(3) and 170(c), contributions to which are

deductible for federal income tax purposes. No Trustee or private individual shall be entitled to share in the distribution of the Trust Estate upon distribution pursuant to this paragraph.

(C) Determination of Ultimate Beneficiaries. Each year the then serving Family Trustees shall meet on December 25, or such other date as the Trustees shall select, to determine, by unanimous vote, the organizations to which the Trust Estate should be distributed upon termination of the Trust pursuant to paragraphs (A) or (B) of this Article, and the portion of the Trust Estate to be distributed to each, provided that any organization so selected is then a qualified charitable organization described in Sections 501(c)(3) and 170(c), contributions to which are deductible for federal income tax purposes. No Trustee or private individual shall be entitled to share in the distribution of any of the Trust Estate upon distribution pursuant to this paragraph. A list of the selected organizations and their respective shares of the Trust Estate shall be filed with the original Trust Agreement. If in any year the Family Trustees shall fail to meet or to make the determination required under this paragraph, then the decision of the Family Trustees at the last prior such meeting shall control. Notwithstanding the foregoing, the then serving Family Trustees may at any time prior to the death of the second Donor determine, by unanimous vote, the organizations to which the Trust Estate should be distributed upon termination of the Trust pursuant to paragraph (B) of this Article, subject to the restrictions otherwise set out in this paragraph, and any such determination shall prevail over any prior such determination. In the event that the survivor of the Donors elects to extend the term of the Trust by amending this Agreement pursuant to Article SIXTH paragraph (A) and Norma Oliason shall serve as the Overseer Trustee pursuant to Article EIGHTH paragraph (C), the Overseer Trustee and any then serving Family Trustees shall determine by majority vote the organizations to which the Trust Estate shall be distributed upon termination of the Trust, and such determination shall prevail over any prior determination.

SEVENTH: Tax Exempt Status.

(A) Direction to Obtain Tax Exemption. The Trustees shall perform all acts as are necessary to obtain recognition of this Trust, by the Internal Revenue Service and by all other relevant taxing authorities, as an organization exempt from tax under Section 501(c)(3) and as an organization contributions to which are deductible for federal income tax purposes under Section 170(c).

(B) Administration as a Charitable Organization. Anything in this Agreement to the contrary notwithstanding:

(1) The Trust Estate shall be held and administered in such manner that this Trust shall at all times qualify for tax exemption under Section 501(c)(3), and this Trust shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt from tax under Section 501(c)(3) or by an organization contributions to which are deductible under Section 170(c).

(2) The Trust Estate shall be held and administered in accord with the provisions of RCW 11.110.210 and RCW 11.110.220, providing that the Trustees are prohibited from:

(a) Engaging in any act of "self-dealing," as defined in Section 4941(d), which would give rise to any liability for the tax imposed by Section 4941(a);

(b) Retaining any "excess business holdings," as defined in Section 4943(c), which would give rise to any liability for the tax imposed by Section 4943(a);

(c) Making any investments which would jeopardize the carrying out of any of the exempt purposes of the trust, within the meaning of Section 4944, so as to give rise to any liability for the tax imposed by Section 4944(a); and

(d) Making any "taxable expenditures," as defined in Section 4945(d), which would give rise to any liability for the tax imposed by Section 4945(a).

(3) Every provision of this Agreement shall be construed and interpreted and, if necessary, modified or limited in such manner that the provisions of this Trust, including every power and duty of the Trustees, shall (a) comply with every provision of the Code necessary to qualify this Trust for tax exemption under Section 501(c)(3); (b) comply with every provision of the Code necessary to qualify this Trust as an organization contributions to which are deductible under Section 170(c); and (c) comply with the provisions and prohibitions of RCW 11.110.210 and RCW 11.110.220.

EIGHTH: Successor and Additional Co-Trustees.

(A) **Additional Trustees.** One or more additional persons may be appointed at any time to serve as Co-Trustee or Co-Trustees of this Trust by unanimous vote of the then serving Family Trustees. The then serving Family Trustees shall also have the power, in their sole discretion, to remove any additional person as Co-Trustee at any time by unanimous vote.

(B) **Successor Trustees.** Should any Family Trustee fail or cease to serve, his/her Trustee position shall be eliminated and the remaining Trustees shall not be required to designate a successor Trustee in his or her place. Notwithstanding the foregoing, in their sole discretion, the then serving Family Trustees may, by unanimous vote, appoint a successor. The then serving Family Trustees shall also have the power, in their sole discretion, to remove any such successor at any time by unanimous vote.

(C) **Trustees on Death of Second Donor.** In the event that the Trust shall terminate on the death of the second Donor, pursuant to Article SIXTH paragraph (A), then Norma Oliason shall become the Overseer Trustee of this Trust for the purpose of distributing the Trust Estate in the manner set out at Article SIXTH paragraph (C), and any other then serving Trustees shall cease to serve. The Overseer Trustee shall in such case notify the organizations to which the Trust Estate shall be distributed pursuant to Article SIXTH paragraph (C) as soon as practicable, and shall oversee the distribution of the Trust Estate to such organizations in an expeditious manner. In the event that the survivor of the Donors elects to

extend the term of the Trust by amending this Agreement pursuant to Article SIXTH paragraph (A), then Norma Oliason shall, upon the death of the second Donor, become the Overseer Trustee and shall serve along with any then serving Family Trustee(s). Any then serving Trustee who is not a Family Trustee shall cease to serve at such time. In the event that the survivor of the Donors elects to extend the term of the Trust by amending this Agreement pursuant to Article SIXTH paragraph (A), the Overseer Trustee shall notify the organizations to which the Trust Estate shall be distributed pursuant to Article SIXTH paragraph (C) no later than the last day of the extended term of the Trust and shall oversee the distribution of the Trust Estate to such organizations in an expeditious manner. In the event that Norma Oliason serves as the Overseer Trustee upon the death of the second Donor, she shall have the authority, by a signed written instrument filed with the original Trust Agreement, to appoint a successor Overseer Trustee for purposes of distributing the Trust Estate, or, if she does not appoint a successor Overseer Trustee, then Rick Starkenburg shall succeed Norma Oliason as the Overseer Trustee. If Rick Starkenburg is unwilling or unable to serve as the successor Overseer Trustee, then the Trustees serving at such time shall, by unanimous vote, select an alternate to serve as the Overseer Trustee. In the event that Norma Oliason is unwilling or unable to serve as the Overseer Trustee upon the death of the second Donor (whether or not this Agreement is amended to extend the term of the Trust), then the Trustees serving at the death of the second Donor shall, by unanimous vote, select an alternate to serve in place of Norma Oliason as the Overseer Trustee, after which selection the then serving Trustees shall cease to serve. In the event that the then serving Trustees are unable to select an alternate Overseer Trustee within six (6) months of the death of the second Donor (whether or not this Agreement is amended to extend the term of the Trust), then the Trust shall terminate, the Trustees shall, at the completion of such six (6) month period, notify the organizations to which the Trust Estate shall be distributed pursuant to Article SIXTH paragraph (C) and the Trust Estate shall be distributed in the manner set out in Article SIXTH paragraph (C) in an expeditious manner.

(D) Succession of Trustees; Bond. Any Trustee may resign and any successor Trustee may act as Trustee without the need to comply with the provisions of any state law regarding the resignation or succession of Trustees. No successor Trustee under this Agreement shall be liable for any act or omission of a predecessor or obligated to inquire into the validity or propriety of any such act or omission. Any such successor Trustee shall be entitled to accept as conclusive any accounting and statement of assets furnished to such successor by a predecessor or by the personal representative of such predecessor and shall further be required to receipt only for those assets included in such statement. No Trustee serving hereunder need give bond, in any jurisdiction. If a Trustee's bond may not be dispensed with in any jurisdiction, the Donors request that the bond for the Trustees be accepted without surety and in the lowest possible amount.

(E) Compensation of Trustees. None of the named Trustees and no successor Trustee shall receive compensation for attending meetings of the Trustees, provided, however, that Norma Oliason, and any alternate or successor Overseer Trustee, shall be compensated for attending meetings of the Trustees at such person's regular professional hourly rate for the lesser of actual time spent in travel and attending meetings of the Trustees, or eight (8) hours per calendar day. A named Trustee and any successor Trustee who renders services in addition to attendance at Trustees' meetings may be reasonably compensated, either at an hourly rate or otherwise, as determined by the Trustees. So as to remove all doubt, Norma Oliason, and

any alternate or successor Overseer Trustee, shall be compensated at such person's regular professional hourly rate for services rendered to the Trust in addition to attending meetings of the Trustees. All Trustees shall receive reimbursement of reasonable travel expenses in connection with attending meetings of the Trustees.

NINTH: Administrative Provisions.

(A) **Powers.** Subject to the provisions of Article SEVENTH, the Trustees shall have all rights, powers, and duties which now exist or may later be conferred by law (including RCW Title 11). Nothing in this Agreement shall be construed to restrict the Trustees from investing the Trust Estate in a manner which could result in the annual realization of a reasonable amount of income or gain from the sale or disposition of Trust property. Any capital gain from the sale or disposition of Trust property shall be allocated to principal.

(B) **Agents and Attorneys.** The Trustees may employ agents and attorneys as the Trustees deem necessary or desirable for the proper administration of the Trust or for any litigation, controversy, or uncertainty which may arise in connection with the Trust. The Trustees may pay reasonable compensation to agents and attorneys for their services and be fully protected in relying on advice of legal counsel. The Trustees shall not be liable for any loss or damage caused by any agent or attorney selected by the Trustees if reasonable care was exercised in selecting and retaining such agent or attorney.

(C) **Special Meetings of Trustees.** Special meetings of the Trustees may be called by any two Trustees. Notice of the time and place of any special meeting of the Trustees shall be given by the Trustees calling the meeting by mail, facsimile, or by personal communication on the telephone or otherwise at least three (3) days prior to the date on which the meeting is held. Attendance of a Trustee at any meeting shall constitute a waiver of notice of the meeting, except when the Trustee attends a meeting for the purpose of objection to the transaction of any business because the meeting is not lawfully called or convened. Meetings of the Trustees may be held by telephone conference call or any other medium in which all Trustees may hear one another.

(D) **Quorum and Voting.** A quorum of the Trustees shall consist of a majority of then serving Family Trustees and a majority of all then serving Trustees. Except as provided in Paragraph (E) below, and Articles SIXTH and EIGHTH above, all actions taken by the Trustees in the administration of this Trust shall require a quorum and approval of (1) a majority of the then serving Family Trustees constituting the quorum and (2) a majority of all Trustees constituting the quorum.

(E) **Administrative Convenience.**

(1) Any individual Trustee may, with the consent of all other Co-Trustees, delegate any power, right, or duty to another Co-Trustee. The delegation shall be effective upon delivery of a signed, written instrument of delegation to the Co-Trustee and the Co-Trustee's acceptance of the delegation. The delegation may be revoked in the same manner.

(2) One Trustee may give written notice to all other co-Trustees of a proposed action. A Co-Trustee's failure to deliver a written objection to such Trustee within fifteen (15) days after receiving notice shall constitute formal approval by such Co-Trustee, unless the Co-Trustee had previously given written notice (then unrevoked) to such Trustee that this fifteen (15) day notice provision shall not apply.

(3) Any individual Co-Trustee may, by written instrument delivered to all other then acting Co-Trustees, relinquish his or her powers, rights or duties, to any extent and upon any terms.

TENTH: Irrevocable Trust.

The Trust created under this Trust Agreement is irrevocable, and the Donors each acknowledge that he/she has no right or power, whether alone or in conjunction with another, and in whatever capacity, to alter, amend, revoke or terminate the Trust or any of the terms of this Trust Agreement, in whole or in part.

ELEVENTH: Limited Power of Amendment.

Notwithstanding the provisions of Article TENTH, the Trustees shall have the power, acting alone, to amend this Agreement only if and to the extent necessary to qualify the Trust as a tax exempt organization under Section 501(c)(3) and as an organization donations to which are deductible for federal income, gift and estate tax purposes. In addition, upon the death of one of the Donors, the survivor Donor, in his or her capacity as a Trustee, shall have the power, acting alone, to amend this Agreement solely for the purpose of extending its term, to the extent provided in Article SIXTH paragraph (A).

TWELFTH: Definitions and Construction of Terms.

(A) **Plurals; Gender.** Unless some other meaning and intent is apparent from the context, the plural shall include the singular, and vice versa, and masculine, feminine, and neuter words shall be used interchangeably.

(B) **References to RCW, Code and Section.** All references in this Trust Agreement to "RCW" are to the Revised Code of Washington and shall refer to corresponding provisions of subsequent Washington laws. All references to "Code" are to the Internal Revenue Code of 1986, as amended, and all references to "Section" or "Sections" are to such section(s) of the Code and shall be deemed to refer to corresponding provisions of subsequent federal tax laws.

(C) **Family Trustees.** All references in this Trust Agreement to "Family Trustees" refer to the four initial Trustees named in this Trust Agreement (DAVID R. BISHOP, LYNDIA F. BISHOP, GINGER SCHMERSAL and AMANDA BISHOP).

(D) **Overseer Trustee.** All references in this Trust Agreement to the "Overseer Trustee" refer to Norma Oliason, or her successor or alternate Trustee, who shall serve upon the death of the second Donor, whether or not this Agreement is amended to extend the

term of the Trust pursuant to Article SIXTH paragraph (A), for the purpose of distributing the Trust Estate in the manner set out at Article SIXTH paragraph (C).

(E) **Fail or Cease to Serve.** All references in this Trust to a Trustee who fails or ceases to serve refer to the Trustee's death, resignation, or a determination by a licensed physician that the Trustee is no longer capable of managing his/her financial affairs.

THIRTEENTH: Governing Law.

Washington law shall govern the execution and construction of this Agreement. The administration of this Trust, however, shall, unless otherwise required by law, be governed first by the provisions of this Agreement, including any laws incorporated in this Agreement by reference or otherwise made applicable by this Agreement, and second, to the extent consistent with such provisions, the laws of the Trust's situs. To the extent permitted by law, the Trust and Trustees shall be exempt from all registration requirements, and the Trust shall be administered by the Trustees free from the jurisdiction and control of any court.

IN WITNESS WHEREOF, the Donors and the Trustees have executed this Trust Agreement as of the date first above written.


