There is a staff of approximately seven to serve the needs of workers utilizing the facility daily from 10:00 a.m. to 9:00 p.m. The Center is also utilized to conduct weekly Catholic Mass.

Recreation Programs - Consist of a variety of recreational activities available to stable workers located at the major California racetracks of Santa Anita Park, Fairplex Park, Golden Gate Fields, San Luis Rey Downs, Del Mar and Hollywood Park. Trips are offered to water and amusement parks, to professional sporting events, such as baseball and soccer games. There are also various coordinated softball and soccer leagues, as well as weekly tournaments (i.e., pool, dominoes, poker, etc.) for all workers wishing to participate.
