Our schools provide educational opportunities for over 600 students. 2013 programs included teacher salaries, school fees for needy primary and secondary school students, college tuition for three students, and construction of a kitchen and dining hall for the primary school.

Merrueshi Village Clinic provides basic healthcare to approximately 5000 Maasai residents of Merrueshi and surrounding communities. 2013 programs included salaries for medical and support staff, and operating expenses.

4c (Code:) (Expenses \$ 10,000 including grants of \$ 10,000) (Revenue \$)

Through the waterhole restoration program Maasai Association has been able to restore natural waterholes originally formed by elephants for the benefit of wildlife and livestock. This conservation program reduces wildlife and human conflict. While 2012 saw the completion of this seven year program, work continued on the final waterhole into 2013.
