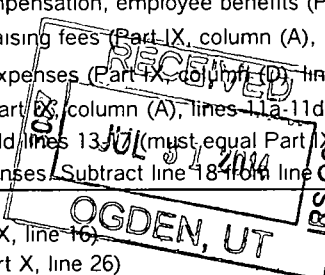

After-School Program: The What If? Foundation funds an after-school program that offers over 200 youth tutoring as well as classes in English, computer skills, gardening, sewing and other skills that help them succeed in school and might one day them earn a living.
