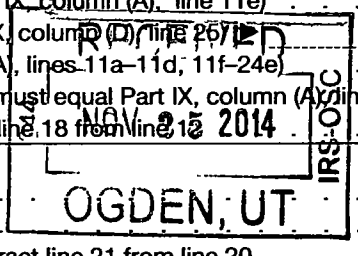

The Great White Shark Project

The Great White Shark Project in Gansbaai, South Africa is a world-leading organization dedicated to the conservation of the world's greatest predator, the great white shark and its environment. Negative publicity has made the shark the most maligned, misunderstood, even hated species on the planet. Founded in 1989 purely as a research center the Great White Shark Project's environmental advocacy seeks to correct negative misconceptions and stop needless slaughter of over 100 million sharks annually. The project educates and works with eco-tourists, volunteers and local enthusiasts to observe and gather data on great white sharks. Over the years the Great White Shark Project has grown and broadened its reach by establishing a commercial arm and funding a non-profit organization, the South African Shark Conservancy.

In 2013 the Great White Shark Project hosted over over 40 international volunteers recruited by the Lion Foundation. These volunteers received hands-on practical experience working with great white sharks, including cage diving, data collection, and the recording of observations. When not at sea, these volunteers received lectures on great white shark biology, behavior, bite incidents and research; not to mention the practical aspects of small-boat handling, snorkeling and diving. Lectures often included data on other species like cape fur seals and southern right whales. Volunteers also made a trip to the South African Shark Conservancy where some experienced a small shark dissection.

Project #2

The Centre for Rehabilitation And Education (C.A.R.E.)

Situated within a Big-5 reserve in the South African province of Mpumalanga, C.A.R.E. is a specialist rehabilitation center for South Africa's chacma baboons. At any time an average of 450 baboons of varying ages are housed and fed in the center's large enclosures. The majority will be organized into viable troops and released in time. Former South African president Nelson Mandela came to observe and assist at one of these releases. But there are also a number of sanctuary cases - animals rescued from labs, often too old or injured to be released back into the wild. Most of the animals arrive at C.A.R.E. as babies, orphaned after their mothers are shot, trapped, poisoned, or otherwise killed. A staff of animal keepers prepares food for the larger baboons and cleans the majority of the enclosures. Volunteers assist with the food and bottles for the younger baboons. A large number of veterinarians and others specifically seeking experience with primates come to C.A.R.E. to volunteer and provide more than basic care when medical assistance is needed. C.A.R.E. is predominantly supported by
