HEALTH SERVICES - Health Services primarily constitutes CIFIC's Greater Danbury Community Health Center (GDCHC), which provides primary care services on a sliding fee scale to low and moderate income families who are uninsured or underinsured. Funding is provided by the U.S. Department of Health and Human Services (DHHS), the Connecticut Department of Public Health including Women, Infants and Children (WIC) and School Based Health Center (SBHC) programs, and revenue from its operations.

EARLY CHILDHOOD EDUCATION - Early Childhood Education includes the Head Start, Early Head Start, Care4Kids and School Readiness programs which are operated partially in collaboration with the City of Danbury Public School System. Major funding is through the U.S. Department of Health and Human Services (DHHS), State of Connecticut Department of Social Services (DSS) and Department of Education (SDE). CIFIC provides Head Start preschool and infant/toddler education services to low and moderate income Northern Fairfield County residents. In addition, CIFIC serves special needs children referred by other local and state agencies.
