AVV provides education, prevention, and intervention services for men, women, and children who are at risk of becoming involved, or are currently suffering in a domestic violence relationship, sexual assault, or abuse. Local advocacy and safe shelter is critical to the well-being of hundreds in our service area. In domestic violence situations where there is a call out to law enforcement (Valdez Police or Alaska State Troopers), the law now determines that someone will go to jail. Many times the perpetrator, who is now in jail, may have been the primary financial support of the family. This often leaves the victims hungry, penniless, and at times, without transportation. AVV offers victims and their families resources for safety, shelter, information, advocacy, and healing.
