The organization conducted multiple runs and walks in 2013 that were open to the general public. The majority of the events were timed. The events ranged in size from 100 participants to 2900 participants. The focus of all events was to promote running and walking for fitness, fun, health, and overall quality of life.

The organization produced a monthly newsletter that was distributed via email and online, along with a written publication called The Oregon Distance Runner which was issued every other month during the year. The newsletter and printed publication highlighted events available for individual participation, included health and nutrition information, and articles on running, walking, road racing, and fitness.

The organization conducted twice-weekly training runs that were open for no cost to the general public.
