Dolphin Campaign. Operation Infinite Patience, Fall 2012-Winter 2013. Each year Sea Shepherd USA sends ground crews -volunteers from around the world - to Taiji, Japan. This small town located in Southeastern Japan, the focus of the Academy Award-winning film The Cove, is a scenic coastal site, but its beauty is stained by the drive hunt, capture and slaughter of up to 2,000 dolphins and other small cetaceans every year. Throughout the six-month 2012-2013 hunt season, our Cove Guardians documented and live streamed each hunt, capture for captivity and slaughter in Taiji, exposing the cruel hunt of marine mammals and applying pressure on Japan to end the slaughter. Our campaign has successfully reduced the number of cetaceans killed, due to the continuous presence of our Cove Guardians throughout the hunt season and has thrust the world's spotlight upon the hunts. This ongoing campaign continues to keep worldwide media, government and public attention on the important issue of the slaughter of highly intelligent, socially complex cetaceans in the world's oceans

Dolphin Campaign: Operation Infinite Patience, Fall 2012-Winter 2013:

Each year Sea Shepherd USA sends ground crews -volunteers from around the world -
to Taiji, Japan. This small town located in Southeastern Japan, the focus of the
Academy Award-winning film The Cove, is a scenic coastal site, but its beauty is
stained by the drive hunt, capture and slaughter of up to 2,000 dolphins and other
small cetaceans every year. Throughout the six-month 2012-2013 hunt season, our
Cove Guardians documented and live streamed each hunt, capture for captivity and
slaughter in Taiji, exposing the cruel hunt of marine mammals and applying pressure
on Japan to end the slaughter. Our campaign has successfully reduced the number of
cetaceans killed, due to the continuous presence of our Cove Guardians throughout
the hunt season and has thrust the world's spotlight upon the hunts. This ongoing
campaign continues to keep worldwide media, government and public attention on the
important issue of the slaughter of highly intelligent, socially complex cetaceans
in the world's oceans.

Sea Lion Campaign: Dam Guardians, Spring 2013

From March to May 2013, Sea Shepherd volunteers were present at the Bonneville Dam and at the Port of Astoria to monitor the hazing, branding and killing of California sea lions by the Oregon and Washington Departments of Fish and Wildlife. The Dam Guardians documented the harassment of these protected marine mammals in photos and video to spread awareness, publicized the needless killing, and educated about the scapegoating of sea lions, as well as the true causes of the decline in the salmon population in the Columbia River: overfishing, pollution, dam turbines and more. Up to 368 California sea lions face execution by the states of Oregon and Washington for the "crime" of eating endangered salmon. State authorities are allowed to kill up to 92 of these federally protected sea lions annually until June, 2016. The sea lions are branded with hot irons, hazed with rubber bullets and explosives (that create a virtual war zone for local residents as well) and are killed by lethal injection or shotgun for eating only 1-4% of the salmon at the dam. This war on wildlife is conducted on the taxpayer's dime and takes place while commercial, sport and tribal fisheries are allowed to take up to 17% of the same endangered salmon, and the dam itself claims approximately 17% of the adult salmon. Sea Shepherd USA's mere presence on site to defend the sea lions and report on their mistreatment and killing has brought attention to this important issue. We also collaborate with other national and grassroots NGOs to join forces in opposition to this ongoing nightmare for sea lions on the Columbia River.

Galapagos: Protecting the Galapagos Marine Reserve

Since 2000, Sea Shepherd USA has maintained a strong, positive presence in the

Galapagos Islands. Home to some of the most diverse and stunning wildlife in the world, the Galapagos are a UNESCO World Heritage Site. Sea Shepherd USA has worked in cooperation with Galapagos authorities to support efforts to protect this unique and sacred ecosystem and the wildlife within from the threat of poaching, patrolling the Galapagos Marine Reserve to help oppose illegal shark finning and other poaching activities.

Sea Shepherd USA funded and built an Automatic Identification System (AIS) to facilitate efforts by the Galapagos National Park Service to monitor vessels operating within the Galapagos Marine Reserve. Sea Shepherd USA has also helped to implement and continues to support an elite police K9 unit. The K9 unit is the first detection of contraband wildlife, and has tracked thousands of illegally smuggled animals and shark fins. In 2013, the first of the wildlife-sniffing police dogs retired and Sea Shepherd USA has ensured continuing care for the other police dogs, including shelter and veterinary treatment.

Sea Shepherd USA has also implemented educational programs and conducts local outreach in the schools to spread awareness of the importance of marine conservation.

Lastly, Sea Shepherd USA has set up a legal project to aid in the prosecution of criminals for crimes against wildlife, as poaching and smuggling are environmental crimes under Ecuadorean law. The legal project, in place since 2010, protects wildlife on the legal front through: (a) attending judicial hearings, as members of the public; (b) attending judicial inspections, as official observers from civil society (c) preparing, submitting and presenting legal briefs known as Amicus Curiae to provide courts with specialized international, constitutional and legal arguments on (i) marine protected areas; (ii) marine protected species; and (iii) world natural heritage. Due in part to this program, poaching in the Galapagos is now

considered a serious crime. Poachers who once received a slap on the wrist and a warning for their crimes are now receiving severe and just consequences, including jail time and significant fines.

UAV Program: Unmanned Aerial Vehicles

A new and developing tactic in the conservation of wildlife is the use of drone technology. Sea Shepherd USA has implemented the use of unmanned aerial vehicles (UAVs or drones) to protect ocean wildlife. This technology provides Sea Shepherd USA with a new and indispensable way to more effectively and safely protect ocean wildlife from slaughter, poaching and illegal operations, as well as to document and spread awareness of these critical issues facing threatened species. These "eyes in the sky" also act as a deterrent to poachers, who know that wildlife and the oceans are monitored.

Plastic Pollution Campaign: The Vortex Project

The Vortex Project is an unprecedented, collaborative campaign, launched by Sea Shepherd, Parley for the Oceans and Bionic Yarn, to clean the oceans of plastic debris and turn this plastic pollution into fashion and other quality, usable products. Throughout 2013, preliminary research and investigative work was performed by Sea Shepherd USA to prepare for this campaign effort.

The Vortex Project takes waste from the oceans and shorelines, and recycles, enhances, and reuses it for yarn, fabric, and other elements in consumer products.

Parley Partners will use the reclaimed plastic waste to create exclusive products with a unique product story. They will also seek to close the loop by again recycling these products at the end their product life and manufacturing new

products in such a way as to not further pollute.

Plastic debris - from the tiniest of micro-plastic to ghost nets and other fishing gear - is ever present in the oceans, even in the most remote waters, and threatens all species of ocean life as well as the health of the ocean ecosystem. The focus of The Vortex Project is to raise awareness about this ongoing and burgeoning issue, collaborate with like-minded individuals in the field of plastic pollution mitigation, and innovate solutions for one of the most significant threats facing ocean life today.
