The treasurer incorporated the committee's suggestions into a final return that was emailed to to all board members before filing.

Form 990, Part VIII Statement of Revenue, and Part IX Reconciliation of Net Assets: For many years the organization has kept its books reflecting investment assets at the lower of cost or market, which is GAAP. The resulting "unrealized" gain or loss has been included in Form 990 filings. Instructions for this part specify that unrealized gains and losses should not be reported on the 990, so 2013 figures have been reported accordingly and 2012 figures have been restated in Part I to reflect proper treatment. The adjustment to 2012 investment income is \$(11,486).

Form 990, Part VIII, Line 1f: The contribution total on line 1f includes a \$23,230 endowment that had been held by the City of McMinnville for the benefit of the McMinnville Public Library. During 2013, this endowment fund principal was transferred to the organization's custody.
