KLAMATH BASIN: SNW IS WORKING TO RESOLVE CONFLICT, BUILD TRUST AND PROPEL EFFORTS FOR WIDE SCALE RESTORATION OF THE ECOLOGY OF THE BASIN. FOR OVER 10 YEARS SUSTAINABLE NORTHWEST HAS WORKED WITH COMMUNITY LEADERS IN THE KLAMATH BASIN TO DESIGN SOLUTIONS THAT BENEFIT FISHERIES, AGRICULTURE AND THE REGIONAL ECONOMY. DRY FOREST ZONE: THE DRY FOREST INVESTMENT ZONE PROGRAM BRINGS A DIVERSE GROUP OF LOCAL AND REGIONAL PARTNERS TOGETHER TO DEVELOP SOLUTIONS THAT CREATE FAMILY WAGE JOBS, RESTORE ECOSYSTEMS, AND INCREASE ENERGY INDEPENDENCE THROUGHOUT THE REGION. THIS REGION COMPRISES 15 COUNTIES WITH DRY PINE AND MIXED CONIFER FORESTS, OF WHICH 68% ARE FEDERALLY-MANAGED PUBLIC LAND. MOST OF THESE FORESTS ARE AT SEVERE RISK OF FIRE AND DROUGHT.
