NAMI (NATIONAL ALLIANCE ON MENTAL ILLNESS) BROWARD COUNTY, INC IS A 501(C)3 NOT-FOR-PROFIT ORGANIZATION, FORMED IN 1982 AND IS AFFILIATED WITH NAMI NATIONAL AND NAMI FLORIDA, TO PROVIDE SUPPORT, EDUCATION, ADVOCACY AND RESEARCH TO INDIVIDUALS WITH SEVERE AND PERSISTENT MENTAL ILLNESS

28 NAMI BROWARD HAD A VERY GOOD AND ACTIVE YEAR IN 2013. WE MAINTAINED OUR MEMBERSHIP IN SPITE OF AN ENVIRONMENT THAT WAS UNFAVORABLE FOR MEMBERSHIP ORGANIZATIONS. WE WERE ACTIVE IN MOST OF THE NAMI SIGNATURE PROGRAMS AND WORKED WITH COMMUNITY ORGANIZATIONS TO IMPROVE THE CARE OF OUR LOVED ONES AND TO ADVOCATE FOR BETTER HOUSING AND MEDICAL TREATMENT. LISTED BELOW ARE SOME OF THE PROGRAMS WE WORKED ON: FAMILY SUPPORT GROUPS ARE AVAILABLE SIX TIMES A MONTH AND CONSUMER SUPPORT GROUPS ARE OFFERED TWELVE TIMES A MONTH. WE RAN SIX FAMILY TO FAMILY CLASSES, INCLUDING TWO IN SPANISH, ONE BASICS CLASS AND THREE PEER TO PEER CLASSES. WE TRAINED TWO FAMILY TO FAMILY TEACHERS IN WASHINGTON, DC TO BECOME STATE TRAINERS. THEY RETURNED TO BROWARD AND TRAINED FIVE FAMILY TO FAMILY TEACHERS. WE ALSO TRAINED FIVE PEER TO PEER TEACHERS AND FIVE CONNECTIONS LEADERS. WE PARTICIPATED IN THREE CIT TRAININGS FOR POLICE OFFICERS THAT GRADUATED ABOUT 75 POLICEMEN AND EMERGENCY MEDICAL PROFESSIONALS TO GIVE THEM A BETTER UNDERSTANDING OF HOW TO APPROACH AND TREAT MENTALLY ILL PEOPLE. WE RAN THREE CONSUMER SOCIALS WITH THE BROWARD COUNTY DEPARTMENT OF PARKS. THESE ARE DANCES FOR ADULTS WITH MENTAL ILLNESS WITH AN AVERAGE ATTENDANCE OF 125 PEOPLE. FOR FAMILIES AND CONSUMERS, WE RAN EIGHT SPEAKER MEETINGS WITH TOPICS OF INTEREST TO OUR MEMBERS. WE RAN NAMI WALKS TO RAISE AWARENESS FOR MENTAL ILLNESS AND TO REDUCE THE STIGMA OF MENTAL ILLNESS. WE HAD 73 TEAMS AND OVER 800 WALKERS. THE GROSS REVENUE WAS 82,000. OUR ANNUAL HOLIDAY PARTY, FREE TO ALL MEMBERS, CELEBRATED THE HOLIDAYS AND RECOGNIZED THE LEADING TEAMS FROM THE WALK. COMMUNITY INVOLVEMENT INCLUDED PARTICIPATING IN THE ADM PLANNING COUNCIL AND COMMUNITY SOLUTIONS COMMITTEE. PRESENTATIONS ON NAMI AND MENTAL HEALTH WERE MADE AT SCHOOLS AND ORGANIZATIONS IN THE COUNTY. A FEW MEMBERS ATTENDED THE NAMI NATIONAL CONFERENCE IN HOUSTON. OUR OFFICE IS STAFFED MONDAY TO FRIDAY FROM 9 TO 5. WE RECEIVED MANY CALLS FROM FAMILIES AND INDIVIDUALS LOOKING FOR HELP FOR THEMSELVES OR THEIR LOVED ONES. OUR PROGRAMS AND ACTIVITIES WERE PROMOTED IN THE NEWSPAPERS, ON OUR FACEBOOK PAGE, THROUGH EMAILS, AND ON OUR WEBSITE.
