CRIME SURVIVOR PROGRAM supports the mobilization of crime survivor voices calling for a more effective public safety system—found not through longer sentences, but through public safety reforms that both prevent crime at the outset and better meet victims' needs. In 2013, Partnership for Safety and Justice worked with survivors of domestic and sexual violence and victim advocates to support "Justice Reinvestment" legislation that doubled funding for Oregon's domestic and sexual violence services programs and created a new funding stream for community-based non-profit victim services beginning in 2015. Crime survivors and victim advocates challenged Oregon's mandatory minimum sentencing structure because it creates a barrier to victims accessing the justice system. Partnership for Safety and Justice is also leading national conversations between victim advocates and criminal justice reformers on together creating a new paradigm on public safety policies that better meets the needs of everyone impacted by public safety policies.

MEMBERSHIP ENGAGEMENT AND PUBLIC EDUCATION The focus of the Membership Engagement and Public Education program is to establish PSJ as a leading source of factual information regarding the need for criminal justice system reform and to support our members' effective involvement in that reform. In 2013, three issues of our newsletter, Justice Matters, reached over 2,100 people with news, issue analysis and resource information. We covered such topics as the need racial impact statements in Oregon, our state's public safety future, and the importance of PSJ's holistic and solutions focused perspective.

SAFETY & SENTENCING PROGRAM develops approaches to public safety that are fiscally responsible, and reduce our over-reliance on incarceration as a response to crime. Education and promotion of the "Justice Reinvestment" approach is a core focus of Partnership for Safety and Justice in its efforts to help build safe and healthy communities by reducing over-reliance on the use of prison and redirecting public resources toward local, evidence-based prevention programs proven to reduce recidivism and future crime.
