

Chewele, Kenya: Funding to help construct a community center that provides additional preventative health care services, and training
and micro-credit small business loans to women and youth that provides self-supporting income for their families.

Arusha, Tanzania: Funding for building a training center for the Naisosion Sewing Project.

Matale, Uganda: Broke ground for the construction of a Girls' Dormitory at St. Andrews Secondary School. St. Andrews has about 420
