Fairytales Town is a children's storybook park and educational center whose mission is to promote the imagination, creativity and education of children. Fairytales Town is home to 28 three-dimensional play sets based on favorite fairytales and nursery rhymes, a family of 23 rare miniature breed animals, three interactive learning gardens and two performing arts stages within 2.5 acres of lush landscaping. Year-round special events and educational programming introduce literacy and creative experiences to approximately 250,000 visitors each year. By providing children with positive introductions to literature, agriculture, arts and cultures we hope to encourage life-long connections to our community and a greater understanding of the world around us. Now, when most children's activities and entertainment tend to be commercial and passive, Fairytales Town is a physically active, imagination-stimulating alternative-one that is needed more than ever.
