Valuescience—offered "Valuescience: Shedding Illusion to Live Better" at Stanford University spring and autumn quarters in 2013; presented valuescience to more than five hundred individuals at Magic and in business, school, and other community settings (e.g., Santa Clara University, Stanford Structured Liberal Education, Branner Hall, a Stanford student residence with a public service theme, Stanford-Thai Exchange Program), hosted former resident and author Pamela Olson to present her recently published book, *Fast Times in Palestine* to an audience of fifty. Residential Education: twenty interns and affiliates from throughout the US, and from Asia, Europe, and South America participated for one to several months; eight were accepted for longer stays. Resident Fellows provided interns and affiliates more than one thousand hours of guidance in living in valuescience-based service learning community.

Liveable City hosted 34th annual Evergreen Park Neighborhood Association picnic, continued a vendor donation program through which we collected and processed fifteen tons of food surplus from the California Avenue Farmers' Market for use in programs of Magic and of Innvision and Community Services Agency, local organizations serving low-income clients.

This responsibility included supervision of Magic resident interns and operating personnel.
