Over 300 miles of the Smith are included in the Wild and Scenic River System, which was created in 1964 to "protect outstandingly remarkable scenic, recreational, geologic, fish and wildlife, historic, cultural or other similar values, for preservation in a free-flowing condition."

The watershed exemplifies the biological diversity of the Klamath/Siskiyou bioregion. Its floral diversity supports a rich assemblage of mammals, birds, reptiles, and fish including black bear, mountain lion, wolverine, northern spotted owl, Chinook and coho salmon, steelhead, and coastal cutthroat trout.

Additional program accomplishments included: SRA has led the CA campaign to block a proposed strip mine in the headwaters of the Smith and Illinois Rivers; served as the facilitator and coordinator for the Interagency Visitor Center project, which involves 14 agencies, entities, and Tribes working cooperatively to develop a shared visitor-serving facility at the Crescent City Harbor. SRA also implemented a program plan at Rock Creek Ranch to host and promote seasonal experience trips and outings for adults, youth and families thereby growing an essential stakeholder group for the SRNRA. The Ranch served as the "home base" for these experience trips and outings. SRA launched public education and interpretive initiative for the Lake Earl Wildlife Area. SRA continues to work to safeguard the important habitat at the Lake Earl Wildlife Area.
