CONFLICT OF INTEREST POLICY FOR BCA ENDOWMENT FOUNDATION

The Board of Directors of the BCA Endowment Foundation hereinafter referred to as "BCAEF" has the responsibility of administering the affairs of the BCAEF honestly and economically and, of exercising their best care, skill, and judgment to carry out the mission of BCAEF. Therefore, it is imperative that those individuals who, by virtue of their positions, can influence the actions of or commit BCAEF or its related agencies in financial and confidential dealings be ever mindful of potential conflicts between the duties imposed by their position and their other interests.

The purpose of this statement is to clarify the duties and obligations required by the Board of Directors, Officers of the Foundation, Executive Director, among others, in the context of the conflict of interest problem. With respect to actual or potential conflicts of interest, this statement sets forth the procedure by which such conflicts must be disclosed and establishes the policy concerning resolution of such conflicts that arise within the provisions of the policy.

I.

Persons concerned.

This statement is directed to the Board of Directors, Officers, Executive Director and employees of the BCAEF. These persons are referred to herein as "individuals".

II.

Areas in Which Conflict May Arise.

Conflicts of interest may arise in relations with entities which may affect the financial or other activities of BCAEF including by way of example:

1. Suppliers of goods and services;
2. Entities with which BCAEF is dealing or plans to deal in connection with the lease, purchase or sale of real or personal property;
3. Donors or other persons giving to BCAEF;
4. Other entities which affect the operation of BCAEF.

III.

Nature of Conflicting Interest

If any individual's relations with the persons, firms or entities mentioned above exist, a material conflict of interest may be defined as an interest which may affect, or may be thought by others to affect, the judgment or conduct of the individual, such as but not limited to:

1. Owning stock or other proprietary interest;
2. Holding debt or debt securities;
3. Holding office, serving on the Board of Directors, participating in management or being otherwise employed or formally employed;
4. Receiving remuneration for services with respect to individual transactions;
5. Receiving gifts or unsecured loans. (Receipt of any gift is disapproved except gifts of nominal value which would be courteously refused. No gifts of money should ever be accepted);
6. Obtaining an interest in real estate securities or other property which BCAEF is considering buying or leasing; and
7. Disclosing or using information relating to BCAEF's operations for the personal profit or advantage of the individual.

IV.

Other Interests.

An individual would also be considered to have an interest in a firm or transaction which may affect the operation of BCAEF with respect to influencing the actions of or committing BCAEF in financial other dealings where any of the following may have an interest:

1. The immediate family of the individual;
2. The estate or trust of which the individual or member of the individual's family is a beneficiary, personal representative or trustee; or
3. A company of which a member of the family of the individual is an officer, director or employee in which the family member has a stock interest or other proprietary interest.

V.

Interpretation of the Statement of Policy

The areas of conflicting interest listed in Section II, the nature of the conflicting interests listed in Section III, and other interest relationships listed in Section IV are not offered as exhaustive expositions. It is conceivable that conflicts may arise in other areas or through other activities or through other relations. The individual is responsible for recognizing such areas, activities, and relations by analogy. The fact that one of the interests described in Section III exists does not mean necessarily that a conflict exists or that conflict, if it exists is material enough to be of financial importance. However, it is the policy of BCAEF's Board of Directors that the existence of any interest such as are described in Sections III and IV shall be disclosed and that the authorization of the Board of Directors shall be required before any transactions involving an interest as described in Sections III or IV is consummated. It shall be a continuing responsibility of recipients of this statement to scrutinize their activities and transactions for potential conflicts and make appropriate disclosures.
