Tools for the Farmer

Our Farm to Market program helps connect farmers to new sales opportunities, increasing their customer base and income. This year, we helped to make over 500 connections between farmers and businesses. We also provided sales/marketing advice, resources and one-on-one consultations to farmers, reducing their financial risk. In addition, our Food Safety Manager created food safety plans for over 70 growers and participated in 24 food safety workshops. We held several dry farming workshops, teaching wine grape growers how to use water more sustainably.

Voice for the Farmer

CAFF has been advocating for family farmers and a more sustainable agriculture in the California legislature for over 35 years, and we continue that work today by defending family farmers' right to sell their product directly to the public without onerous regulation, as task made more difficult by rapidly escalating environmental and food safety rules. We have spent years trying to limit the impact of the Federal Food Safety Modernization Act on family farms, and we expect this struggle to continue in the future. In 2013, we passed a law defining CSAs as farm-based direct marketers and we are now developing a network of CSAs in California with the intention of better promoting them to the public. In 2014 we expect to work on legislation

Food for your Family

CAFF's Farm to School program educates students about healthy eating through farm field trips, in-class lessons, and our Harvest of the Month (HOTM) program, which delivers produce to school classrooms so teachers can take the lead on food and farming education, and students can taste fresh fruits and vegetables from local farms. We also offer apprenticeship opportunities for older youth and assist school food staff with local procurement. During the past school year, our HOTM program reached over 193,000 students! We began a Buy Fresh Buy Local education campaign in the Santa Clara Valley region, introducing community members to the farmers who grow their food, and teaching them about healthier food choices and how to buy local products.
