In particular, the liturgical resources and homily hints, in English and Spanish, continue to be provided in print, on YouTube channels, and through a smartphone app. These liturgical resources cover every Sunday of the three-year liturgical cycle. In 2013, Priests For Life also announced the beginning of the Cardinal John O'Connor Institute for the Pro-life Training of the Clergy, which will expand and make even more accessible its clergy education in 2014.

Pro-Life State and Federal Legislation-Priests for Life is fostering support for the Pain Capable Unborn Child Protection Act, a measure that protects unborn children after 20 weeks due to the child's capacity to feel pain. We were involved in initial strategy sessions to launch the attempt to pass such laws on the state level, and the legislation has now been enacted in ten states. Priests for Life strongly supported the successful efforts of the House of Representatives to pass this measure in June of 2013, and was involved in the introduction of the measure in the US Senate. We are launching a project to publicly ask each Senator to answer the question as to whether they support protection of children in the womb from painful dismemberment abortion after 20 weeks of development. This is part of a series of interrelated public education projects on late-term abortion that Priests for Life is conducting to replicate the successful strategy behind the ban on partial-birth abortion by presenting the question of what the public thinks of a particular abortion procedure, rather than just what they think of abortion in general.

Expose Abortion- Priests for Life has launched a new project to expose the reality of abortion. On the website ExposeAbortion.com, on the Facebook page Facebook.com/ExposeAbortion and on the Twitter account @ExposeAbortion, one quote per day is provided from abortionists, medical texts, court testimony, those who have had abortions and from other sources reveal the damage abortion does to babies and their mothers. People are urged to spread this information far and wide.

Silent No More Awareness Campaign- This Campaign, the world's largest mobilization of women and men who have lost children to abortion continues to hold gatherings throughout the world at which these brave individuals share their testimonies publicly. In doing so, they reveal the pain of abortion as the mercy of Jesus Christ. The Campaign launched two initiatives. One focuses on fathers utilizing the expertise of those who help post-abortive men and the other gives fathers and mothers the opportunity to memorialize online the children they have lost to abortion at UnbornMemorials.com. The Campaign held 1,325 Gatherings in 48 US states and 17 countries with 6,716 women and men sharing their testimonies. Testimonies have been shared at 14 high schools and universities in 2013. There are 2,014 testimonies posted on the website of which 293 shared a video. There are 14,979 people registered with the Campaign representing 77 countries.

HHS Lawsuit- Priests for Life was among the first groups to file a federal lawsuit against the Obama Administration's HHS Mandate which forces virtually all employers to provide insurance coverage for contraceptive and abortifacient "services". That lawsuit was dismissed in April 2013 but only after the government stipulated that it would not enforce the mandate against Priests for Life. Revisions to the mandate were issued but they did not satisfactorily resolve the moral and legal concerns of Priests for Life, therefore a lawsuit was re-filed. The judge ruled against Priests for Life and we requested an injunction which is currently in force.

Life on the Line- On EWTN new episodes of *Defending Life* were aired. Also our Executive Director, Janet Morana co-hosted *The Catholic View for Women* which aired in the fall. Various members of our pastoral team did hundreds of interviews for local, national and international print and broadcast media. Priests for Life continued to provide daily one-minute radio spots both in English and Spanish on EWTN, Bott Radio and Radio Maria.

Year of Faith Pilgrimage- Priests for Life organized a pilgrimage to Rome for one of the official events of the Year of Faith which was the observance of a Day for the Gospel of Life. There was 150 who attended and Fr Frank Payone and Janet Morana personally met Pope Francis.

Prayer Campaign- Priests for Life promotes unceasing prayer among the faithful for the cause of life. The prayer website www.prayercampaign.org as well as the Facebook cause www.ProLifePrayers.com provides the faithful with specific pro-life prayers.

Hundreds of thousands of prayer cards for various novenas have been disseminated in parishes and at pro-life events throughout the year.

Vatican Collaboration-Helped organize a conference held in Rome in conjunction with the pontifical Council for the Family and an association of Italian Catholic jurists. Fr Pavone gave one of the keynote talks on the progress of the cause of life in the judicial area. Priests for Life promoted the work and publications of the Pontifical Academy of Life and worked closely with the Pontifical Council for Promoting the New Evangelization on promoting the worldwide Day of Evangelium Vitae, an official observance of the Year of Faith. Priest for Life also worked closely with the Holy See Mission to the United Nations.

Youth Outreach-Stand True Ministry-Under the direction of Bryan Kemper, Priests for Life offers inspiration, training and resources to young pro-life activists worldwide. The Stand True exhibit booth was one of the most popular booths at conventions like the March for Life and Students for Life of America. Stand True organizes the annual youth rally held before the March for Life. This event had over 1,000 youth's in attendance. Stand True has also been at the Cleveland Right to Life Conference, Oregon Right to Life Conference and the National Right to Life Conference. Bryan was also gave keynote talks in Australia and represented Priests for Life at the World Youth Day in Rio.

Rachel's Vineyard - Priests for Life collaborates closely with and helps to fund Rachel's Vineyard, the world's largest retreat program ministry for women and men seeking assistance with grief resolution following pregnancy loss. Rachel's Vineyard completed their Spanish retreat manual and they have over 50 Spanish retreat sites. They gave various talks in London, Canada, Australia and Ecuador.

African-American Outreach - Alveda King, niece of the eminent civil rights leader Dr. Martin Luther King, Jr. and Director of the organization's African-American Outreach program networks with hundreds of prominent African-American pastors and Christian leaders authors and media personalities. She has attended approximately 58 pro-life events, conducted over 200 interviews and helped strengthen the National Black Pro-life Coalition.

Hispanic Outreach-Fr Victor Salomon taped a new series of "Defendiendo la Vida" which aired on EWTN, he also hosts the weekly live show "Evangelio de Vida" on Radio Maria. He oversaw the translations into Spanish of many of our pro-life materials.
