Programs: Recognized for original research, policy analysis, education and advocacy, in 2013 we received a MacArthur Award for Creative and Effective Institutions. We responded to the World Bank's re-entry into financing mega-dams by building a network of civil society partners in Africa and the Himalayas, and launching a "Power 4 People" campaign to redirect public financing toward renewable energy alternatives that alleviate poverty and promote climate resilience. After years of dialogue, we convinced Sinohydro (China's biggest dam builder) to adopt an environmental policy consistent with international standards, including World Bank safeguards. We built alliances with civil society and indigenous groups in Peru resisting a cascade of dams proposed in the headwaters of the Amazon River. We provided media support to Chilean groups organizing to oppose dams on the wild rivers of Patagonia.

Communications: We continued to produce multi-language content through our website, videos, reports, blogs, online actions, emails, and social media to raise awareness about the ecological and social consequences of damming rivers, and the sustainable alternatives available for our water and energy needs. We released and disseminated three major reports, translated into several languages: the "Civil Society Guide to Healthy Rivers and Climate Resilience," and "An Introduction to Integrated Resources Planning." We also organized the annual March 14 International Day of Action for Rivers to bring attention to the threats facing the Earth's rivers and to celebrate the people working to protect them.
