APEN held a CLEAN! Festival that brought out 200 community residents of Richmond California to enjoy the power of the sun and learn about renewable energy, transit-oriented development and equity. APEN founded the Richmond Environmental Justice Coalition and helped lead a "landscape scan" to aide in the development of new policies to responsibly transition to a low carbon future. APEN's efforts also resulted in the passage of two Richmond City Council resolutions that hold Chevron accountable for the health and environmental impacts of the August 6, 2012 refinery explosion and stops issuance of permits without sound science.

4b (Code:) (Expenses \$ 255,386. including grants of \$) (Revenue \$ 5,000.)Oakland Program

APEN launched Y-APEN (Youth APEN), a space to bring together young Asian Americans ages 18-25 who support environmental justice, renewable energy, wise land use, and want to connect with other young people. APEN continues to play a leadership role on the steering committee of the Great Communities Collaborative (GCC) which works on an equitable implementation of the Sustainable Communities Strategy initiative within the Bay Area region. APEN completed the second annual APEN Leadership Academy, an eight week course that trains diverse APEN leaders on community organizing, social justice in the United States, APEN campaigns and landscape analysis. These trainings were simultaneously interpreted from English into Khmu, Mien, Cantonese and Mandarin.

APEN played a lead role in the implementation of SB 535, the California Global Warming Solutions Act, which aims to reduce greenhouse gas emissions and funnel resources towards environmental justice organizing efforts. APEN's efforts on this issue helped ensure that program priorities included in the three year Investment Plan of the Greenhouse Gas Reduction Fund (GGRF) will direct investments into working class communities for energy efficiency, solar installation in low income neighborhoods, public transit, affordable transit oriented development (TOD) and urban forestry. Additionally, APEN provided education to decision makers on 20 bills related to various environmental justice issues.
