A TOTAL OF \$394,000 WAS GRANTED OUT OF THE BROTHERTON FUND IN 2013. A GRANT OF \$282,000 WAS PAID TO SUTTER HEALTH WEST FOR THE BENEFIT OF THE ST. LUKE'S CAMPUS (FORMERLY ST. LUKE'S HOSPITAL). THE REMAINING \$112,000 WAS GRANTED TO NINE SAN FRANCISCO ORGANIZATIONS, FOCUSING ON LOCAL COMMUNITIES IN NEED. SERVICES SUPPORTED BY THESE GRANTS INCLUDE ALCOHOL AND DRUG RECOVERY PROGRAMS, EDUCATION AND COUNSELING FOR HOMELESS PEOPLE, AFTER-SCHOOL AND SUMMER PROGRAMS FOR AT-RISK YOUTH, ESL AND OTHER PROGRAMS FOR RECENT IMMIGRANTS.
