These events included sit-ins, marches, rallies, vigils, fasts, press conferences and forums, postcard collection drives, caravans, social media campaigns and creative actions aimed to draw attention in unique ways to farm workers' lives and the need for immigration reform. Moreover, farm workers became spokespeople for their communities by interacting with news media and social media, sharing their stories, and informing policymakers of the needs of farm workers and immigrants.

MEMBER SERVICES

The UFW Foundation educates immigrants about their rights and responsibilities, and helps them access the immigration benefits that may be available to them and/or their family members. In 2013, the organization's Board of Immigration Appeals (BIA) accredited staff assisted 2,009 individuals with low-cost immigration legal consultations and legal representation. Clients were mainly farm workers and other low-income Latino immigrants who reside in California's San Joaquin Valley and Central Coast and in Arizona's Phoenix metro area. The organization helped its constituents apply for citizenship, Deferred Action for Childhood Arrivals (DACA), U-Visas, family petitions, and other immigration benefits.

The organization also provided hundreds of low-income individuals with tax preparation assistance, which helped many families attain the Earned Income Tax Credit. Additionally, close to 3,000 community members were provided assistance with determining eligibility for safety net and health insurance programs such as CalFresh (food stamps), Medi-Cal, Covered California (ACA), Healthy Families, CalWORKs, unemployment and social security.

Notably, the UFW Foundation's outreach in the community reached at least 48,614 people through in person outreach activities. The organization hosted informational sessions to educate the community about workplace health and safety; the eligibility

requirements for safety net programs, the Affordable Care Act, and available immigration relief; and the rights of immigrants (regardless of immigration status). In total, 667 informational sessions and outreach activities were held in California, Arizona, and Oregon.

The UFW Foundation is involved in multiple collaborations focused on preparing for immigration reform or administrative relief. The organization's Executive Director, Diana Tellefson Torres, is co-chair for the communications committee of the Coalition for Immigration Reform Implementation (CIRI) that is being led by the Catholic Legal Immigration Network, Inc. (CLINIC), and is working to develop a national communications strategy that reaches legalization-eligible immigrants with information regarding the law while making sure that it warns against the consequences of receiving assistance from fraudulent providers. The UFW Foundation also is an active participant in a coalition, named Ready California, which is working to make sure that California is prepared for legalization implementation. The group has focused on capacity surveying and education around the importance of capacity building to be able to serve the needs of immigrants. The UFW Foundation helped initiate and continues to participate as a steering committee member in a legalization implementation group called the Central Valley Immigration Integration Collaborative. The collaboration has developed a report detailing the areas of focus for legalization implementation in the region.
