In 2013, the ATP successfully governed the men's professional tennis circuits through its operation of professional tennis events and its promotion of players, tournaments and the sport as a whole The ATP secured a number of significant new sponsorship deals in 2013, with Emirates, Rolex and Tecnifibre all signing deals to partner with the ATP World Tour through 2017 Overall commercial revenues reached record levels, increasing 200% since 2009 The ATP continued to deliver more value than ever to its members through sponsorship and TV revenue for tournaments, prize money and benefits for players, as well as through income revenue streams generated through data distribution and live streaming
