In 2013, the ATP successfully governed the men's professional tennis circuits through its operation of professional tennis events and its promotion of players, tournaments and the sport as a whole. The ATP secured a number of significant new sponsorship deals in 2013, with Emirates, Rolex and Tecnifibre all signing deals to partner with the ATP World Tour through 2017. Overall commercial revenues reached record levels, increasing 200% since 2009. The ATP continued to deliver more value than ever to its members through sponsorship and TV revenue for tournaments, prize money and benefits for players, as well as through income revenue streams generated through data distribution and live streaming

The ATP successfully marketed and promoted men's professional tennis to a worldwide audience in 2013, with a record 4.47 million spectators attending ATP World Tour events, and record audiences on TV and online. The ATP successfully promoted its members through its global BEAT THIS marketing & advertising campaign, PR initiatives, as well as through its weekly magazine show, ATP World Tour Uncovered, which was viewed in more than 150 countries worldwide. More people tuned into the ATP World Tour than ever before, with a record 837 million dedicated television viewers across 185 countries (up 75% since 2008). Total broadcast hours of ATP events increased by 28% globally in 2013, while more than 45 million people followed the ATP and its players and tournaments on social media

The ATP successfully governed the men's professional tennis circuits - the ATP World Tour, the ATP Challenger Tour, and the ATP Champions Tour. The 2012 ATP World Tour season comprised 62 events and saw record prize money of \$83 million, whilst the ATP successfully governed the men's professional tennis circuits - the ATP World Tour, the ATP Challenger Tour, and the ATP Champions Tour. The 2013 ATP World Tour season comprised 61 events in 30 countries, and exceeded \$85 million in on-site prize money for the first time, whilst the ATP Challenger Tour comprised 151 events. A bonus pool totaling 7.5 million was paid out to eligible players competing on the ATP World Tour circuit. In addition, the Season-ending Barclays ATP World Tour Finals welcomed 261,000 fans to the tournament, meaning the event has welcomed more than 1.25 million fans since it moved to London in 2009
