Conservation and Advocacy Program: Nectandra Institute helped finance the acquisition of 12 acres of grazing lands by two local community water management associations. The forest will be restored on the properties in order to increase habitat for the area's biodiversity and the communities' potable water sources that are located just downhill from the newly protected area. In all, Nectandra Institute has helped our local community partners acquire more than 540 acres of land, increasing the protection for the sources of drinking water for 13,000 people through forest conservation and restoration. During the year, we coordinated more than 2,000 person-hours of restoration and monitoring work by approximately 600 people, including tree plantings, tree growth measurements, monitoring water flows from springs and in streams on or near the protected lands in order to track changes in volume and regularity over time that may be influenced by the restoration of the forest cover, and systematic photo-documentation of this restoration over time.

Community Outreach and Education Program: Outreach and education efforts were directed primarily to the rural communities of Costa Rica's upper Balsa River Watershed. Almost 30 educational presentations were given during the year on topics related to conservation, ecology, and environmental protection/restoration. Nectandra Institute helped organize and sponsor the 6th annual "New Culture of Water" Month, which consists of several events and activities during the month of September aimed at educating people and raising awareness for protecting forests, watersheds, and water resources. Several short, educational videos were produced and shared publicly online and via local television.

Research and Information Program: Stream water quality at 23 different sampling points within the upper Balsa River watershed was tested using methods that involve microbiological laboratory analysis, as well as a method that involves tracking populations of certain types of aquatic macroinvertebrates that are known to be either tolerant or intolerant to contaminated waters.
