The Urban Peace program reduces and prevents community violence, making poor neighborhoods safer so that children can learn, families can thrive and communities can prosper Urban Peace has made significant strides in improving safety in Los Angeles communities by increasing the skills, knowledge and professionalism of public and private stakeholders working to reduce youth gang violence Now in its eighth year, the Urban Peace Academy (UPA) has trained 2,400 gang violence interventionists, school leaders, parks and recreation workers and community residents Over 800 gang interventionists are now certified to work for the Los Angeles Citys Gang Reduction and Youth Development program And 900 law enforcement officers and over 400 LAPD officers have been trained The UPA also provided training for gang intervention and community workers implementing the highly successful Los Angeles and Long Beach Summer Night Lights programs to work in the Citys 32 SNL Parks

Ending the Schoolhouse to Jailhouse Track Project The Ending the Schoolhouse to Jailhouse Project works with grassroots organizations throughout the country to examine, expose, and reform practices that lead to the criminalization of students We support work on the ground, build capacity for community-led work, and build bridges amongst those working to end the schoolhouse to jailhouse track Across the country, school systems are shutting the doors of academic opportunity on students and funneling them into the juvenile and criminal justice systems The combination of overly harsh school policies and an increased role of law enforcement in schools has created a school-to-prison pipeline, in which punitive measures such as suspensions, expulsions, and school-based arrests are increasingly used to deal with student misbehavior, and huge numbers of youth are pushed out of school and into prisons and jails In many communities, this transforms schools from places of learning to dangerous gateways into juvenile court This is more than an education crisis, it is a racial justice crisis, because the students pushed out through harsh discipline are disproportionately students of color

Healthy City is an information and action resource that unites community voices, research and technology to solve the root causes of social inequity in California In 2013 we engaged over 3,060 community stakeholders and nonprofit professionals In each setting, participants learned to incorporate data and geographic development in their community improvement efforts Healthy City helped philanthropies such as The California Endowment, The California Wellness Foundation, and First 5 Los Angeles make more equitable and targeted investments in the health of communities The Community Research Lab (CRL), a program that helps community-based organizations lead and sustain their own research, spent most of 2013 preparing for the expansion of our community research workshops across the state and to new audiences Through some of our partnerships, we updated, translated into Spanish, and implemented some of our workshop curriculums to communities in Boyle Heights, Watts-Willowbrook, and Long Beach
