

In 2013, CIFOR continued its Board-approved research strategy focused on six research themes, supported through its programs focussing on Livelihoods, Governance and Environment. CIFOR championed the importance of a landscapes approach. CIFOR scientists have continued to identify emerging areas of research such as migration. With projects are operating in over 30 countries investing in key relationships with local and international partners. CIFOR continued to lead the operations of the CGIAR Research Program on Forests, Trees and Agroforestry (FTA). CIFOR further participated in the CGIAR Research Program on Climate Change, Agriculture and Food Security (CCAFS).

In 2013, the Information Services Group supported CIFOR's research programmes by providing state-of-the-art technical services, library facilities, computer services and electronic communications.

In 2013, CIFOR's output of scientific publications included books, technical papers and reports, policy briefs, journal articles, newsletters, research abstracts, and book chapters. CIFOR together with key partners led the inaugural Global Landscapes Forum on the sidelines of the United Nations' annual climate change discussions. The success of the Forum in initiating cross-sector knowledge sharing and collaboration has cemented it as an annual event that CIFOR will lead.
