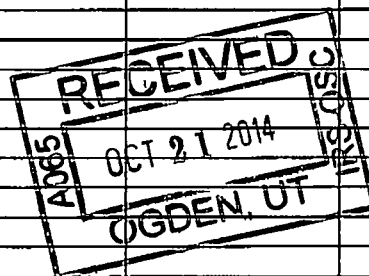

As explained below, the taxpayer has not been fully funded, but, in prior tax years, received partial distributions from the Original Foundation (defined below) that were fully distributed in the tax year of receipt to its sole beneficiary, American Friends of Hebrew University. In the 2013 tax year, the taxpayer did not receive a partial distribution and, thus, made no distributions to American Friends of Hebrew University during the 2013 tax year.

The taxpayer is a successor entity to a grantor trust (treated as such for federal income tax purposes) also named Strasal Stiftung (such grantor trust being referred to as the "Original Foundation"). The Original Foundation was established on September 20, 1996, under the laws of Liechtenstein at the direction of Mrs. Ann L. Oppenheimer. During her lifetime, Mrs. Oppenheimer was the sole beneficiary of the Original Foundation. Per Article 2 of the Regulations of the Original Foundation's governing documents, at Mrs. Oppenheimer's death, after distribution of specific dollar bequests to three named charities, the remaining assets of the Original Foundation are to be set aside in the taxpayer, a Section 501(c)(3) charitable foundation, for the sole benefit of the "Julius Oppenheimer Endowment Fund" of the Hebrew University and charitable distributions are to be made to American Friends of Hebrew University, a recognized Section 501(c)(3) public charity, in order to benefit such fund.

Mrs. Oppenheimer died on January 25, 2008. Mrs. Oppenheimer's estate participated in the IRS's Voluntary Disclosure Program for off-shore accounts and income tax liabilities were assessed on the grantor trust's income. The payment of such income tax liabilities are the subject of a suit against the Original Foundation filed in the New York County Surrogate's Court, purportedly on behalf of Mrs. Oppenheimer's estate. The Original Foundation may be subject to other liabilities as a result of claims that have been alleged against it in a separate suit also filed in the New York County Surrogate's Court. The Board of the Original Foundation has not waived any of its rights or positions in connection with either proceeding. The Board of the Original Foundation has determined that the taxpayer (i.e., the charitable fund) cannot be further funded unless and until the issues leading to these potential liabilities are resolved. Upon settlement of these potential liabilities as well as any other claims that may arise, it is expected that the remaining assets of the Original Foundation will be transferred to the taxpayer and the taxpayer will be fully funded.

Due to uncertainty regarding the potential liabilities discussed above, the Board of the Original Foundation deemed it prudent to make no distribution to the taxpayer in the 2013 tax year. The taxpayer generated no other income, incurred no expenses, and had no assets or liabilities during the 2013 tax year.
