### PART III - Statement of Program Services

The Overbrook Monarchs, Inc. were organized to serve disadvantaged youth in the Philadelphia neighborhoods that lacked school or city funded sports programs. To help address the gap in youth services, we launched a youth sports program that now operates year round. The Monarchs provide young people with rigorous athletic training in basketball, football, lacrosse, track and cheerleading. Our mission is to promote community and social empowerment, using sports as a vehicle to help young people reach higher achievement in education while developing a sense of social responsibility and self worth. Our organization cultivates an experience that promotes positive thinking and positive action among the at-risk youth we serve.

The Monarchs organization has been in existence 10 years and has had many success stories of youth that have participated in our programs. These youth remain active in high school and college sports and excel academically as well.

The Monarchs currently have approximately 600 youth participating in our programs.
