Peru Volunteer Program. In 2013, 129 young people participated in our volunteer program, which is oriented towards fostering understanding of Peruvian culture as well as professional development in the areas of medicine, music, education and engineering. We executed 12 medical campaigns serving 1333 patients and invested more than 14,840 volunteer hours and \$11,100 in material donations and community outreach to promote development in Peru. Volunteers also participated in health prevention and education workshops reaching 490 community members as well as 3 Christmas events where over 600 toys were distributed to children in the community. Volunteers also traveled to Cusco and visited Machu Picchu to learn about the roots of the Incan culture and appreciate the rich history of Peru.
