Augmentative and Alternative Communication - This program provides comprehensive augmentative alternative communication (AAC) services and devices as people with ALS lose the ability to move and speak. People with ALS are provided with information and resources, in home or clinic evaluations, and equipment loans. These methods include low tech and high tech communication options including alphabet boards, laser pointers, iPad communication apps, and electronic eye gaze communication computer aids for daily living. Home visits may be made by an AAC specialist to provide training on new devices and evaluating on-going needs.

Patient Support and Care For Kids Funds - Caring for someone with ALS is expensive and the financial impact on a family is usually two-fold. As the ALS progresses, the family will likely lose that person's income and others in the home may have to quit their job(s) to provide care. In the later stages of the disease, people require power wheelchairs, hospital beds, respiratory equipment, and professional 24 hour care and costs can easily exceed \$200,000 per year. This situation leaves many children with a parent suffering from ALS without any resources to enjoy simple childhood experiences such as summer camp, music lessons or playing team sports. The Golden West Chapter provides "scholarships" so that children may have these types of experiences. Each scholarship is \$300 and is limited to two scholarships per household. In the event a family may have more than two children, the scholarship award may be split among all the children in order to assist the family with sending all the children to camp or another program. In addition to the scholarships, the Chapter from time to time will pay for a care giver or special therapy if the family is unable to pay for it. Expenses \$ 6,514. including grants of \$ 5,424. project ever created and is designed to better describe the following factors of ALS: how common ALS is in the United States; examine risk factors, such as environmental and occupational exposures that might be associated with the disease; identify factors such as age, race or ethnicity, sex, and family history that may be associated with the disease; and better examine the connection between ALS and other motor neuron disorders that can be confused with ALS, misdiagnosed as ALS, and in some cases progress to ALS.

Through the purchase of tablets and data plans, the Chapter's goal was to significantly increase enrollment in the National ALS Registry over the course of one year. In order to meet the goal of increased enrollment, the Chapter trained all Chapter Care Services and Events staff in the National ALS Registry process to:

- a) Increase participation in National ALS Registry of the current Chapter patient population served to 50%
- b) Establish a protocol to inform 100% of new patients about the National ALS Registry
- c) Provide National ALS Registry assistance onsite at Chapter clinics, home visits, events, and other patient-oriented engagements.

This cost center continues to fund the production of the Chapter eNewsletter and the maintenance of patient data records.

The Chapter produces 12 eNewsletters a year which are sent to over 17,000 constituents, with the most up to date Chapter news, research updates, care services educational tools, and Chapter events. It is the primary communication tool for the Chapter to reach people with ALS
