FUNDS ARE ALLOCATED FOR UTILITIY ASSISTANCE (HEATING AND COOLING), RECONNECTION ASSISTANCE AND EMERGENCY FURNANCE REPAIRS/REPLACEMENT. THE PROGRAM IS IMPLEMENTED IN ACCORDANCE WITH GUIDELINES PROVIDED BY THE DEPARTMENT OF COMMERCE AND ECONOMIC OPPORTUNITY. DECATUR-MACON COUNTY OPPORTUNITIES COUNCIL (DMCOC) SERVED APPROXIMATELY 5,666 HOUSEHOLDS. THE WEATHERIZATION PROGRAM HAS PROVIDED A MUCH NEEDED BENEFIT TO MACON COUNTY INCOME ELIGIBLE RESIDENTS IN THE PAST FOUR YEARS. DMCOC HAS BEEN ABLE TO WEATHERIZE 671 HOUSEHOLDS SINCE 2009 TO MAKE THEM SAFER AND MORE ENERGY EFFICIENT THUS LOWERING THEIR POWER BILLS. DMCOC'S GOAL IS TO WEATHERIZE AS MANY LOW-INCOME

ANNA WATERS HEAD START PROGRAM IS SPONSORED BY THE DECATUR-MACON COUNTY OPPORTUNITIES CORPORATION. IT IS A COMPREHENSIVE CHILD DEVELOPMENT PROGRAM. DMCOC PROVIDES SERVICES TO THE ENROLLED CHILDREN AND THEIR FAMILY, WHICH MAKES THE PROGRAM UNIQUE. HEAD START MAINTAINS A FUNDED ENROLLMENT OF 378 STUDENTS THROUGHOUT THE PROGRAM YEAR. DMCOC OPERATES TWO SESSIONS (8:30-12 AND 12:30-3:30). THE CHILDREN ATTEND AFTER SCHOOL FOUR DAYS PER WEEK (MONDAY - THURSDAY). DOOR TO DOOR TRANSPORTATION IS ALSO PROVIDED. THE PROGRAM ENHANCES THE CHILD(REN) CONFIDENCE, SELF-EXPRESSION, DISCIPLINE AND CURIOSITY BY PROVIDING EDUCATIONAL AND SOCIAL OPPORTUNITIES. CHILDREN ALSO RECEIVE PHYSICAL EXAMINATIONS, ORAL EXAMS, IMMUNIZATIONS, AND NECESSARY MEDICAL TREATMENT.
