The Court finds the following:

1. This Court has jurisdiction over the subject matter and parties in this proceeding.

3. Daniel Cardinal DiNardo, Archbishop of the Archdiocese of Galveston-Houston, corporate sole is the owner and operator of Holy Family Catholic School.
4. Moody National Bank, is the Trustee of a testamentary trust (the "Trust") created under the June 10, 1958 Will (the "Will") of Fred Wimhurst, Jr. ("Wimhurst") for the benefit of students of Ursuline Academy of Galveston, Texas ("Ursuline Academy").
5. O'Connell High School Foundation known as O'Connell College Preparatory High School ("OCPHS") is a non-profit corporation.
6. Ursuline Academy of Galveston is a Texas nonprofit corporation which formerly owned and operated Ursuline Academy in Galveston, Texas.
7. Because of changed circumstances the testamentary trust created under the Last Will and Testament of Fred Wimhurst, Jr. should be modified so as to continue carrying out the settlor's intent. The changed circumstances are the Trust terms

required Moody National Bank to distribute fifty percent (50%) of the Trust's income for the benefit of needy students who desire to attend Ursuline Academy, and sometime after the year 2030, the construction of a chapel at Ursuline Academy in memory of the deceased members of the Wimhurst Family. 8. This Court may modify a testamentary trust pursuant to Section 112.054 of the Texas Property Code entitled "Judicial Modification or Termination of Trusts."
9. The Texas Attorney General, received notice of this suit and Agreed Judgment pursuant to Section 123 of the Texas Property Code and elected not to intervene.
10. Moody National Bank and Ursuline Academy of Galveston entered into a 1981 and 1986 agreement that modified the terms of the Trust; however, such modifications have not yet been approved by this Court.

Therefore, the Court ORDERS that the testamentary trust created under the Last Will and Testament of Fred Wimhurst, Jr. be modified as follows:

3. Moody National Bank shall distribute the funds to Holy Family Catholic School and O'Connell High School Foundation known as O'Connell College Preparatory High School no less than semi-annually, equally between Holy Family Catholic School and O'Connell High School Foundation known as O'Connell College Preparatory High School which shall utilize such funds to

pay the tuition of needy children pursuant to guidelines previously established (and as amended) by Holy Family Catholic School and O'Connell High School Foundation known as O'Connell College Preparatory High School.

4. The Trust shall terminate per its original terms; however upon termination, and remaining Trust principal and undistributed income shall be divided equally between Holy Family Catholic School and O'Connell High School Foundation known as O'Connell College Preparatory High School or their successors and such funds shall be used in furtherance of Catholic education on Galveston Island.

The Court further ORDERS that the 1981 and 1986 agreements between Moody National Bank and Ursuline Academy of Galveston are approved and ratifies all distributions from the Trust to Holy Family Catholic School and O'Connell High School Foundation known as O'Connell College Preparatory High School and their predecessors.

The Court further ORDERS that to acknowledge the gift from Wimbhurst and the contributions made to Ursuline Academy and to Galveston Island by the Ursuline Sisters, the following shall be done within six months from the date of this Order:

1. Holy Family Catholic School shall rename its chapel the "Ursuline – Wimbhurst Family Memorial Chapel" and erect a recognition plaque;
