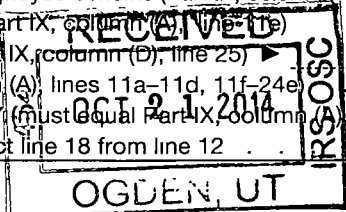

All requests for funds from the Washoe County Sheriff's Office for equipment, supplies and training that are approved by the executive staff are paid directly to the equipment, supply or educational organization. All funds donated to charitable organizations are paid directly to the local chapter of the organization for use in the community. The "Annual Shop With The Sheriff" and Fourth Street Corridor programs for indigent children are supervised by volunteers from the Honorary Association and Washoe County Sheriff's Office employees. The programs support indigent children and their families nominated by various local public and charitable organizations as qualifying for federal assistance. The gift cards use for the event are purchased from Wal Mart for approximately 250 children with volunteers supervising the children's purchases. Typically the money spent by the children exceeds the amount of the gift card with the volunteers absorbing the additional costs from their own pockets. Limitations are imposed on the children in regard to the types and amounts spent. No public grant funds were obtained or distributed by the Honorary Association. All dues/donations/private grants earmarked for a specific purpose are explained to the members/grantors prior to the collection of he dues/grants/donations including providing the literature explaining the use of the funds to advance the needs of the Washoe County Sheriff's Office. The members and grantors are given copies of any invoices for training, edquipment and supplies acquired prusuant to dues/donations/grants. Recipients of training and the users of new equipment and supplies typically either speak with the donors/grantors and/or attend the quarterly membership meetings to recount the benefits of their training or to display and discuss the equipment and supplies acquired. The Senior Mangement Institute Program (SMIP), Southern Police Institute (SPI) and Leadership in Counter-Terrorism Programs (LNCT) Training Tuitions are flat fee.
