The Board of Governors meets two times a year for approximately three hours each meeting, plus an annual meeting of about 1/2 hour. All governors are volunteers, serving without pay. As Tournament hosts, the governors spend approximately one hour a week for about six months a year on Association business, exclusive of meetings.

The Secretary and the Treasurer each spend about two hours a week for six months a year preparing Tournament notices, maintaining membership records, collecting, posting and depositing dues and initiation fees, paying bills, keeping financial records and completing and filing IRS forms 990 and 1099/1096.

The tournament Director is an independent contractor who makes all the arrangements with the various golf clubs for holding the tournaments and serving meals, and super
vises during the tournaments.
