BOTH OF THESE PUBLICATIONS CONTINUE TO EXTEND THE MISSION OF THE COLLEGE TO DISSEMINATE SCIENTIFIC ADVANCES IN THE FIELD. THE JOURNAL'S IMPACT FACTOR HAS REACHED 8.678, RANKING 6 OUT OF 129 IN PSYCHIATRY, 8 OUT OF 260 IN PHARMACOLOGY, AND 16 OUT OF 251 IN NEUROSCIENCE.
