28 Maternal Newborn Community Health The Maternal Newborn Community Health (MNCH) program is committed to delivering medical treatment, healthcare services, education and counseling to newborn healthcare communities in Africa. The year began with the opening of a new community health unit. MNCH worked with the new county governments and their health structures, composed two research proposals that were approved by the Kijabe Ethics Committee, and submitted a manuscript which is under review for publication. The program continued to add and develop additional community health volunteers who receive training maternal newborn material in additional (new) geographic areas. MNCH staff continue to work in development of the community health agenda at the national level with their participation in the technical work group for operational research and the national curriculum in community health. A new Kijabe College of Health Sciences is under development and MNCH looks forward to developing the School of Community Health through their program. Their hope is to have all the structures in place for admitting new students to a certificate course in March 2015. The release of the five year Kijabe Newborn Community Health report has raised the profile of the project. It has a presence on Kijabe Hospitals web site (<http://kijabehospital.org/services-specialities/medical-services/community-services/newborn-community-health-clinic>) where the five year report resides as well as other developments including a webinar from the program director on Maternal Health done in conjunction with the Her Dignity Project to promote womens issues. MNCH purchased and donated a vehicle to Kijabe Hospital. The vehicle allows transportation of staff to training sites, supports the local government health management team with transportation to do household registration in the Utugi Community Unit, and helps transport many different community health volunteers, greatly increasing our productivity in the regions we serve. The program was able to support Kijabe Hospital further by partially funding the purchase of a new portable X-Ray machine. The purchase has made a dramatic difference in the quality of care given to out sick babies in the nursery since it eliminates the need of having to hook up an oxygen tank and walking through cold corridors to the x-ray department to look at endotracheal tube placement and check for other conditions. Such improvements are of extreme importance when providing care to premature babies.

29 Infectious Disease The efforts to advance infectious disease training and capacity has focused on laboratory diagnostic capacity, on training of residents and fellows in infectious diseases, infectious diseases consultation for patients with infectious diseases, and improvement in hospital infection control. The Infectious Diseases (ID) program attempted to begin a medical technology bachelors degree program modeled after North America but it was turned down. However, ID developed a one year hospital-based training program that has been approved and will begin soon. For infectious disease fellowship training, discussions are underway with University of British Columbia for collaboration in training. The hope is to begin training in January 2015. ID has also planned their initial infection control course, principally for nurses working in infection control positions. The first portion is scheduled for October 2014.
