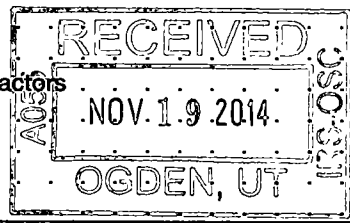

**Form 990EZ, Page 2, Part 3 - What is the Organization's primary exempt purpose?:**

Legacy Fellowship partners with an in-country NGO for community health projects in Niamey, Niger. They are currently working in two communities. Two Health Committees have been started and are obtaining government recognition. In these two communities, 77 Community Health Educators have been trained. The Educators are helping raise awareness with 16 community associations representing 470 individuals. Topics include malaria prevention, diarrhea treatment and prevention, importance of clean water, health of pregnant women and newborns and small-scale gardening. Much time has been devoted to the conception of teaching materials and translation into national languages that are appropriate for the members of the community.
