**Children and Youth Programs**  
ServeNow works with disadvantaged children, orphans as well as street children in centers located in some of the major slums in India. In some locations schools from Kindergarten to Grade 4 are in operation; in other areas children are taught to read and write, as well as taught life values through teaching, drama and music. Through special summer programs the children are taught lessons from the Bible.

**Scripture and Church Teaching Programs**  
One of the major projects of ServeNow is to assist local congregations in remote areas and in the slums, providing such churches with basic Scriptures. Pastors are also trained in major themes of church teaching. ServeNow also provides training materials for each member in these congregations on a long term basis. Individual training programs are also conducted in strategic locations in each country.

**Humanitarian Programs and Team Mission Trips**  
In areas where it gets freezing cold and children and elderly have no winter coverings, we provide winter clothing (currently to approximately 3,000 people), in remote villages and in slums. ServeNow provides day medical camps, with national physicians and nurses, seeing approximately 150 patients a day. These camps take place almost every week in a different location. In the summer when drinking water is scarce, such is provided for a month for individual families. To train young women in a trade, to void them being drawn into trafficking, ServeNow operated several tailoring schools as well as cosmetology schools.  
The short term teams provide additional needed staffing for a variety of humanitarian and other ministry programs. It also allows individuals to have a life changing experience by spending two weeks in international settings, working alongside nationals in projects like providing winter clothing in areas where many of the recipients otherwise may freeze to death or become gravely ill. Team members may also assist national doctors and nurses in medical camps as well as providing free drinking water in areas where no water is available.
