KACAP was the lead recipient for a regional consortia grant that was administered by the federal Office of Community Services, under the auspices of the federal Department of Health and Human Services' Administration for Children and Families. A primary responsibility KACAP had was to sub-grant funds to the Community Action state associations in Iowa, Missouri and Nebraska. Of the total funds listed, \$261,925 was sub-contracted, and KACAP used the remaining funds for sub-grantee oversight and for Kansas specific programmatic activities

KACAP hosted the 2013 Kansas Conference on Poverty, a statewide training event designed to provide increased knowledge and skills to anti-poverty practitioners and advocates. The event was attended by 257 individuals and provided 37 training opportunities. Of the participants responding to event evaluations, 96% increased their understanding and knowledge.

KACAP facilitated multiple training sessions and provided technical assistance for specific professional peers groups in Kansas' Community Action Network, including Human Resource Professionals, Fiscal Professionals and Agency Management/Leadership Professionals. 100% of participants in training events and best practice meetings continued to express the value of their participation in peer group opportunities, and also 100% indicated in post-meeting/training evaluations that they increased their knowledge on topics/issues related to their work duties.

In addition to the major programs highlighted in Part III line 4a–c, KACAP was also involved in the following programmatic activities: 1) provided mission-related training and technical assistance to member agencies and other social service organizations in Kansas, 2) participated in staff and professional development activities, 3) worked with other social service organizations on both the state and national levels on anti-poverty issues, and 4) educated individuals and organizations about the Kansas Community Action Network and poverty-related issues.
