Wood River Land Trust Program Achievements

4/1/2013 – 3/31/2014

River Health and Restoration:

We continued our restoration work around the **Bow Bridge of the Big Wood River**. The Bow Bridge is one part of the WRLT's Hailey Greenway Restoration Project. The Bow Bridge is an integral part of our objective to allow people to experience nature, as the bridge itself is a draw for our community and visitors to visit and experience the Hailey Greenway. As people visit special places, they begin to take ownership and pride in the health of the area, thus helping WRLT manage it. We hope this connection with nature will inspire our community and Wood River Valley visitors to become more involved with land protection and restoration.

We began our Sixth year of our **Trout Friendly Lawn program** which is an educational and proactive program addressing how local yard care impacts the health of the Big Wood River and its fishery. Educational sessions for property owners and local landscaping companies showcased the benefits of using organic non-toxic applications, native plants, and efficient low-impact watering systems to conserve water. Home, local municipalities and business owners were encouraged to conduct a watering audit of their yard by a trained professional in order to find ways to conserve water. Yards that meet certain water conservation and protection requirements are certified as Trout Friendly. Local businesses and other nonprofits partner with WRLT on this program. Over 150 lawns and businesses were certified.

As part of the **Trout Friendly Lawn** program the Wood River Land Trust planted draught tolerant grass at one of its employee houses and also developed an informative video on how to convert a lawn to be draught tolerant. The program is ongoing and growing.

We started work again on our **Riverbank Restoration** in Lion's Park which extended the WRLT's Hailey Greenway. This area was once a city dump and the Wood River Land Trust in cooperation with local government organizations and the Idaho Department of Environmental Quality removed 1,200 tons of dump material in 2008. Funded through the generosity of **Project Wow** students, we were able to continue our restoration project along the Big Wood River. Over 120 native shrubs were planted by students along the river bank to reduce erosion and to rid the area of noxious weeds and plants.

Project development and outreach continued for the **River Restoration at Sunpeak and the Hulen Meadows Pond**. We conducted an Environmental Assessment (EA) of the project and the project is being reviewed by the Bureau of Land Management. This EA and its review were funded in part by the Wood River Land Trust. The project's goal is riparian and river area restoration and improvement of public recreational opportunities. In 2010 surveying and floodplain analysis were conducted and we completed the study for the hydrological and restoration work, flood plain analysis, project analysis, mapping, topographic assessments, initial consultant reviews, approval by the City of Ketchum and legal consultation for stream restoration, flood plain analysis and project analysis which needed to be completed prior to the on-the-ground implementation of any restoration work.

The Wood River Land Trust continued its work to reestablish enhanced year-round stream flow in the **Big Wood River channel below Magic Reservoir dam**. We invested an additional \$12K with a consulting firm to provide us with various options in order to have year-round stream flow below the dam. The project's work has primarily consisted of the collaboration with the Big Wood Canal company to consider the release of water year-round in order to reestablish the fishery and riparian area as close to its historical condition as is possible. Outside of the spring/summer irrigation season, no water is released from the dam and the river becomes a trickle as it is comprised solely of water from various low flow springs. In autumn and winter the shutting off of the water can result in a substantial fish kill when stranded fish die from lack of oxygen or water. This manipulated and inconsistent stream flow also disrupts wildlife and normal plant life cycles.

Staff organized **volunteer work days** at riparian/floodplain areas at Boxcar Bend, Howard Preserve, Croy Creek Wetland and Draper Wood River preserves on the Big Wood River, with emphasis on control of noxious weeds.

Land Stewardship:

Staff monitored all thirty-nine (39) of the Wood River Land Trust conservation easements totaling 10,519 acres to ensure compliance with individual easement restrictions/language and to note any changes in the property. All monitoring data, such as photo points, were reported and entered into the permanent record.

We also continued to monitor 1,062 acres of our thirteen (13) fee simple properties located in and adjacent to the Wood River Valley. These preserves are maintained in their natural state and/or restored to a healthy landscape. Stewardship staff address such ongoing problems as noxious weeds, trash, vehicle incursions, erosion and trail upkeep.

Land Acquisition/Protection:

The Wood River Land Trust acquired 7.5 acres, called the **East Fork Preserve**. This easement was donated in 2002 to Blaine County but we have been responsible for stewardship of the property for the County. In 2013 the East Fork Preservation Association made a fee simple donation of the 7.5 acres to the Wood River Land Trust. This property is located between Hailey and Ketchum at the intersection of 75 and East Fork Road and continues along the highway. The protected land provides passersby with undeveloped views of the East Fork Canyon. This area is protected from development in order to preserve its scenic views and provide travelers with an appreciation of the valley's beauty for years to come.

In December of 2013 the WRLT also acquired our thirty-ninth (39) easement named the **Gateway Easement**. This donated easement consists of 84.9 acres of scenic wetlands and pasture. The property is located at the "gateway" to the Wood River Valley – hence its name.

The staff began the purchase process of a 10,400 acre property called Rock Creek Ranch which is west of Hailey, Idaho. This property was homesteaded in 1923 and was once platted to be another community in Blaine County. Through a large collaborative effort with local, state, and national government organizations, and other NGOs, we plan to close on this property through a bargain sale in 2014. By protecting Rock Creek

Ranch, we defend the benefits you and others derive from the land – for our health and enjoyment. Recreational trails, wildlife habitat, working lands that provide food, intact scenic views and clean, fresh water are just a few reasons that compelled us to safeguard the Ranch.

Through our staff's collaborative work with the **Pioneer's Alliance** we were able to aid ranchers and property owners to protect 65,400 acres through the Grasslands Reserve Program.
