

In FYE 3/31/2014 the entity transferred an approximately 25,000 square foot Medical Office Building to Casa Colina Hospital for Rehab Medicine, a related organization, at construction cost of \$6,872,324. The Medical Office Building is adjacent to Casa Colina Hospital's existing inpatient and outpatient operations on it's Pomona Campus and offers an opportunity to expand the scope of services available to Casa Colina patients. Currently the Medical Office Building rents to an urgent care center, an outpatient retail pharmacy, a durable medical equipment supplier and physician offices.

Exploration, analysis and research of hospital based outpatient physical (including specialty clinics: pain management, multiple sclerosis and vestibular), occupational and speech therapy programs served within the community. Expenses include salaries, benefits, consulting, professional fees, advertising, marketing and supplies. Revenues from sales of certain items in the gift shop and other gaming revenue from raffles and related events are used to offset the amount of other donations required to fund these expenses.

Restricted and unrestricted funds transferred to affiliated tax exempt corporations for either, the provision of charity care services and community benefits to individuals who otherwise had no other source of income to pay for needed rehabilitation, or support services provided subsequent to compliance with donor restrictions. Also, to fund programs involved in areas such as autism, preventative medicine, wound care, health and wellness and programs which assist individuals who have suffered brain and other traumatic injuries in developing self-esteem thru recreational activities.
