- The organization provides up to eight ballet productions annually, including the New York International Choreographers Festival, and a fully staged Nutcracker using acclaimed guest artists and Broadway sets. The events celebrate New York's talent pool of artists, performers, musicians and theater crafts professionals, providing a vibrant venue of dance on Staten Island, which is still recovering from multibillion-dollar losses from deadly Hurricane Sandy 2 years ago. Free tickets are given to other not-for-profits and financially challenged homes. Our Dancing Over Walls program gives free, unlimited dance classes to youths in need; our Children and Seniors Children Together (C.A.S.T.) program is an inter-generational program helping both young and seniors explore their mutual realms in special free performances. About one-quarter of our 220 students receive free or subsidized training. A summer Performing Arts Intensive provides dance, literacy, music and drama training. The organization is housed in a four-story NYC landmark building, it rescued and rehabilitated into a dance conservatory in a long-term lease with NY city, for which the organization won a preservation league award. The organization has built an active and loyal arts organization over the past 2 years, serving a working-class borough of 500,000. Tuition received: \$270,230; Scholarships given \$59,000 (as waived tuition); tickets sold \$44,061

Paul Tharp, Executive Director, and a co-founder of the organization, provided a line of credit of up to \$180,000 in 2012 for the organization to cover emergency costs and unexpected deficits due to devastation of Hurricane Sandy in late 2012, causing several deaths and wrecking the local economy, leaving in excess of \$1 billion in damages and losses. The local economy is still recovering, causing a serious impact on arts in the community. The line of credit, guaranteed and secured by Paul Tharp through Santander Bank, was provided interest-free to the organization, and is repayable on demand with notice to the Board of Directors. There is no expectation of default, due to liberal terms in repayment scheduling and continuing forbearance during the economic setback to the local economy.

The line of credit has increased to \$251,400, fully documented in banking and financial records detailing all sources of funds and deposits.

Several emergency loans made by the director to the organization in FY 2014 ended May 31, 2014, to cover expenses and building repairs, had been unintentionally omitted from Quickbooks data entry in a bookkeeper's apparent oversight. The omissions were discovered in audit reviews received by the organization earlier in 2016, about one year after the filing of FY 2014 made in April 2015 when the organization was without auditor representation due to circumstances described previously in Schedule O reports in 2013, 2014 and 2015.

[A.] Part IV Line 1a. The organization's auditor for the prior 5 years resigned abruptly in 2014 despite his pre-paid engagement. That left our auditor reports unfinished for both FY13 and FY 14, as earlier reported by the organization. Following multiple interviews of CPAs, the Board of Directors engaged a new auditor in 2015, Arlia & Associates, 10 Jefferson Blvd, S.I., NY 10312, to conduct reviews of FY13 and FY14 which were made available on May 15, 2016. Our 990 reports for both years, as reported earlier, were filed on time stipulating pending completion of auditor reports. The completed auditor report for FY2014 is submitted herein in an amended return filed on this date May 19, 2016.

Despite our reasonable, best efforts, our financial reports and data were mired 1-1/2 years in an auditor's abandonment of a contract.

The Board and its finance committee review a draft Form 990 at the organization's office in special meetings. At these discussions, members discuss the finances in the context of its mission and our written governance policies, e.g., conflicts, ethics, whistleblower, discrimination. Revisions are primarily a result of the absence of auditor support for 1 1/2 years to remedy a prior auditor's abdication of a signed contract.

Form 990: Several revisions, all due to audit lapses and bookkeeper error, appear on 6 pages, reflecting updated reconciled information.

Part I: Line 8 (Part VIII, line 1h) Contributions: Revised to \$157,091 from \$169,198 due to reclassification of a loan incorrectly reported as "revenue" instead a liability; hence, changes were made in related Revenue fields, e.g. Line 12 (Part VIII, Column (A), line 12)

Part I, Expenses: Lines 13, 15, 17, 18, 19 (related to Part IX, column (A), Lines 1 - 25): the amount in Line 13 was incorrectly reported due to aggregated duplicate expenses, resulting in amended revisions in other expense fields, e.g., Line 15, Line 17. Line 18 was impacted by the duplicated expenses due to inadvertent errors by a temp bookkeeper, which were discovered in subsequent reconciliations of Quickbooks and banking data following new auditor's review, as well as the repair to incomplete Quickbooks file eventually recovered from prior auditor.

Part 1, Assets/Fund Balances: Line 20 (Part X line 16) incorrectly recorded total assets due to an incorrect classification of approximately \$113,731 in leasehold improvements as an "expense" instead of an asset, thus reflecting an inadvertent but significant distortion of Part X Balance Sheet.

Part III, Line 4a: Expenses and Revenue were revised to reflect corrected fields where they appear throughout the amended report.
