CONSTRUCTION OF INTREPID SPIRIT CENTERS ON JUNE 24, 2010, THE INTREPID FALLEN HEROES FUND COMPLETED CONSTRUCTION OF THE NATIONAL INTREPID CENTER OF EXCELLENCE, A 72,000 SQUARE FOOT FACILITY, LOCATED AT THE WALTER REED NATIONAL MILITARY MEDICAL CENTER IN BETHESDA, MD UPON COMPLETION OF THE NICOE, THE FACILITY WAS TURNED OVER TO THE UNITED STATES DEPARTMENT OF DEFENSE FOR STAFFING AND OPERATION. THE NICOE IS TODAY THE DEPARTMENT OF DEFENSE'S PREMIERE FACILITY DEDICATED TO RESEARCH, DIAGNOSIS AND TREATMENT OF TRAUMATIC BRAIN INJURY (CONTINUED ON SCHEDULE O) THE INTREPID FALLEN HEROES FUND HAS EXPANDED THE CAPABILITIES OF NICOE BY IMPLEMENTING A PLAN TO CONSTRUCT NINE INTREPID SPIRIT CENTERS AT MAJOR MILITARY DEPLOYMENT BASES AROUND THE COUNTRY. THE CENTERS WILL ACT AS SATELLITES TO NICOE EXTENDING CARE CLOSER TO HOME FOR TROOPS RETURNING FROM DEPLOYMENT. EACH INTREPID SPIRIT CENTER IS DIGITALLY TETHERED TO NICOE TO ENABLE SHARING OF ADVANCES IN THE DIAGNOSIS AND TREATMENT OF MILITARY PERSONNEL WITH TRAUMATIC BRAIN INJURY. THE FUND HAS LAUNCHED A \$100 MILLION DOLLAR CAMPAIGN TO RAISE FUNDS FOR THE CONSTRUCTION OF THE INTREPID SPIRIT CENTERS. THE FIRST TWO INTREPID SPIRIT CENTERS, AT FORT BELVOIR, VIRGINIA AND CAMP LEJEUNE, NORTH CAROLINA, WERE COMPLETED AND OPERATIONS BEGAN IN JUNE 2013, AND THE THIRD INTREPID SPIRIT CENTER, AT FORT CAMPBELL, KENTUCKY, WAS OPENED FOR OPERATIONS IN SEPTEMBER 2014. GROUND WAS BROKEN FOR INTREPID SPIRIT CENTERS AT FORT BRAGG, NORTH CAROLINA AND FORT HOOD, TEXAS IN 2014. EACH INTREPID SPIRIT CENTER COSTS APPROXIMATELY \$9 - \$11 MILLION TO BUILD.

OTHER PROGRAM SERVICES IN AUGUST 2013, A \$10,000 SUPPORT GRANT WAS GIVEN TO A BRITISH NON-PROFIT, WALKING WITH THE WOUNDED, WHICH TREATS AND ASSISTS BRITISH MILITARY PERSONNEL WHO HAVE SUFFERED SEVERE INJURIES IN THE WARS IN IRAQ AND AFGHANISTAN. THE INTREPID FALLEN HEROES FUND HAS A LONG HISTORY OF SUPPORTING BRITISH SERVICE MEMBERS, WHO WERE INCLUDED IN THE FUND'S ORIGINAL PROGRAM OF PROVIDING GRANTS TO FAMILIES OF MILITARY PERSONNEL WHO HAD BEEN KILLED WHILE SERVING IN UNIFORM. (CONTINUED ON SCHEDULE O) IN SEPTEMBER 2013, \$1,250 IN SCHOLARSHIP SUPPORT GRANTS WERE GIVEN TO EACH OF 5 CHILDREN OF A MARINE WHO WAS KILLED IN JANUARY 2005 DURING OPERATION IRAQI FREEDOM. THE TOTAL AMOUNT OF THE GRANTS WAS \$6,250. THIS GRANT WAS TO A RECENTLY-IDENTIFIED FAMILY OF A MARINE KILLED IN OPERATION IRAQI FREEDOM ACTION PRIOR TO MAY 2005, THEREFORE MAKING THE FAMILY ELIGIBLE FOR THE GRANTS PROVIDED BY THE INTREPID FALLEN HEROES FUND AT THAT TIME.
