

 In FY 2012 PCs for People collected almost 7,000 computers and laptops. Over the course of the year these PCs were refurbished and distributed to low income families. A total of 6,675 PCs were distributed. PCs for People also supports the computers distributed with a 90 day warranty and does discounted repairs after the warranty period. Repairs are \$25 and any parts needed are free. In FY 2012 over 1,900 repairs were completed at an average cost of \$20 per repair.

 PCs for People offered low cost high speed 4G internet to eligible recipients. Almost 10,000 low income families have signed-up.
